SUBJECT: Wildland Firefighting Gear

GENERAL INFORMATION

In April 2013, the Abilene Fire Department was awarded a grant from FEMA's 2012 Assistance to Firefighters Grant (AFG) Program. The approved project cost is \$142,625. The Federal share is 80% or \$114,100 and the City's share is 20% or \$28,525.

This purchase is for 175 complete ensembles of wildland firefighting personal protective equipment (PPE), including jackets, pants, belts, gloves, boots, goggles, and helmets. A \$2,679.50 balance will remain after purchases.

SPECIAL CONSIDERATIONS

Due to some vendor samples not meeting specifications three different vendors will be used to purchase the equipment. All equipment must meet or exceed specifications of NFPA Standard 1977/2011.

Those meeting specifications include:

Metro Fire - Vendor for the jackets, pants, belts, gloves & boots (Meets specifications and low bid) Nafeco - Vendor for the goggles (Only vendor meeting specifications) Ferrara Fire - Vendor for the helmets (Meets specifications and low bid)

Items not meeting NFPA 1977/2011 specifications are goggles from Ferrara Fire and Metro, gloves from Nafeco and boots from Ferrara.

FUNDING/FISCAL IMPACT

Funding for this equipment is available through the 2012 Assistance to Firefighters Grant and the City's budget, 5545-60110 (G5503). Quantities listed are approximate and shall be awarded on a per unit price basis.

\$ 127,527.50 (175 wildland jackets, pants, belts, gloves and boots from Metro Fire)

- \$ 6,118.00 (175 sets of goggles from Nafeco)
- \$ 6,300.00 (175 helmets from Ferrara Fire Apparatus)
- \$ 139,945.50 Total

STAFF RECOMMENDATION

Staff recommends purchase of this equipment in the amount of \$127,527.50 from Metro Fire, \$6,118.00 from Nafeco, and \$6,300.00 from Ferrara Fire.
