SUBJECT: Oral Resolution Awarding Bid for the Northeast and Grimes Water Treatment Plants Sodium Hydroxide and Liquid Ammonium Sulfate Systems Improvements

GENERAL INFORMATION

On February 26, 2014 the City of Abilene received bids for the Northeast and Grimes Water Treatment Plants Sodium Hydroxide and Liquid Ammonium Sulfate Systems Improvements Project CB-1416 (Project). The Project was advertised in the Abilene Reporter News on February 9th and 16th, 2014. Six bids were received. The low bid was submitted by Purcell Contracting Ltd., (Purcell) of Meridian, TX in the amount of \$677,000.00. The Engineer, after evaluating the bid submittal and the contractor references, does recommend awarding the bid to Purcell.

The Grimes Water Treatment Plant (WTP) and the Northeast WTP each utilize an Anhydrous Ammonia Feed System (AAFS) for disinfection using chloramines. The age of each AAFS has resulted in deterioration of feed equipment and piping resulting in operational and reliability issues at each WTP.

Enprotec/Hibbs & Todd, Inc. (EHT) was hired to design a new chemical feed system to replace the AAFS's at those two WTP's. It was determined that Liquid Ammonium Sulfate (LAS) would be a safer and more practical alternative to using Anhydrous Ammonia. The Project includes the installation of new bulk LAS storage tanks, chemical feed equipment, piping and appurtenances at the two WTP's. The existing bulk caustic storage tank at the Northeast WTP will be relocated and replaced with a new upsized tank.

FUNDING/FISCAL IMPACT

The Project will be funded using existing Water Department funds (Unrestricted, designated for capital projects).

STAFF RECOMMENDATION

Staff recommends that the City Council award the bid for the Project to Purcell in the amount of \$677,000.00 and to authorize the City Manager or his designee to execute all necessary documents related to the contract.

Bids for the above referenced project were opened on Wednesday, February 26, 2014. A total of six (6) bids were received, and I have attached a copy of the Bid Tabulation. The apparent low bidder was Purcell Contracting, Ltd. (Purcell) out of Meridian, TX.

Enprotec / Hibbs & Todd, Inc. (eHT) has evaluated the responsiveness of Purcell for conformity with all material conditions of the Advertisement for Bids and the Information for Bidders.

Based on our evaluation, eHT recommends award of the contract to Purcell, for the Northeast and Grimes Water Treatment Plants Sodium Hydroxide and Liquid Ammonium Sulfate Systems Improvements Project, as the lowest responsive and responsible bidder. Purcell's base bid totaled \$677,000.00; we recommend awarding the base bid to Purcell for a total cost of \$677,000.00.

We look forward to working with the City of Abilene as this project moves into the construction phase.
