# SUBJECT: Oral Resolution Awarding Bid for the Lake Abilene Dam Intake Tower Rehabilitation Project.

### **GENERAL INFORMATION**

On June 30, 2014 the City of Abilene received bids for the Lake Abilene Dam Intake Tower Rehabilitation Project CB-1428 (Project). The Project was advertised in the Abilene Reporter News on June 15<sup>th</sup> and June 22<sup>nd</sup>, 2014. Three bids were received. The low bid was submitted by SCR Construction Company, Inc. (SCR) of Richmond, TX. The Engineer, after evaluating the bid submittal and the contractor references, does recommend awarding the bid to SCR in the amount of \$189,250.00.

On June 13<sup>th</sup>, 2013 the Abilene City Council authorized Amendment 2 to the professional services contract with Freese and Nichols, Inc. (FNI) for the Dam Upgrade Program for Fort Phantom Hill Dam, Lake Abilene Dam, and Kirby Lake Dam. Amendment No. 2 provides for second phase engineering services for the preparation of plans, specifications and contract documents for the recommended improvements and construction phase services for Fort Phantom Hill Dam and Lake Abilene Dam. The Project is an improvement resulting from Amendment 2. The dam intake tower structure was completed in 1921, and it has obvious degradation to the exterior surface resulting from continuous exposure to wave action and the elements. The Project is for the encasement of the of the dam intake tower structure using steel reinforced concrete. The current very low surface water elevation of Lake Abilene may allow the contractor full access to the structure to make the repairs. The bid documents provide for an allowance and repair options should the lake level increase before or during project construction.

#### **FUNDING/FISCAL IMPACT**

Funding for the Project comes from the FY 2014 Operating Budget.

## **STAFF RECOMMENDATION**

Staff recommends that the City Council award the bid for the Project to SCR in the amount of \$189,250.00, and to authorize the City Manager or his designee to execute all necessary documents related to the contract.
