A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS CANVASSING RETURNS AND DECLARING THE RESULTS OF THE SPECIAL CALLED ELECTION, HELD ON JANUARY 13TH, 2015.

WHEREAS, on the 23rd day of October, A.D. 2014, the City Council of the City of Abilene, by proper resolution, ordered a Special Called election to be held in said City on the 13th day of January, 2015, in accordance with the provisions of the Charter of said city, for the purpose of electing a person to serve the unexpired term of Council Place 6 previously held by Kellie Miller; and
