SUBJECT: Resolutions to Canvass the Returns and Declaring the Results of the May 9th 2015 Bond & General Election.

GENERAL INFORMATION

City Council duly authorized an election to be held within the City of Abilene, Texas (the "City") on May 9, 2015 (the "Election"), for the purpose of submitting to the resident qualified electors of the City the propositions and elect councilmembers to Council Place 1 & 2 hereinafter set forth in the Resolutions.

The returns were processed immediately following the General & Bond Election; and it appears that Shane Price was unopposed for Place 1 and it appears that Bruce Kreitler received the majority of the votes cast in the General Election for Place 2.

It appears that all Bond Propositions were approved by the voters.

RESOLUTION BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CANVASSING RETURNS AND DECLARING RESULTS OF MAY 9, 2015 BOND ELECTION; PROVIDING AN EFFECTIVE DATE; AND CONTAINING PROVISIONS NECESSARY AND INCIDENTAL THERETO

WHEREAS, the City Council duly authorized an election to be held within the City of Abilene, Texas (the "City") on May 9, 2015 (the "Election"), for the purpose of submitting to the resident qualified electors of the City the propositions hereinafter set forth;

WHEREAS, this City Council has investigated all matters pertaining to said Election; and

WHEREAS, the Election officers who held said Election have duly made the return of the results thereof, and said returns have been duly delivered to this City Council;

WHEREAS, the City Council finds and declares that the meeting at which this Resolution is considered is open to the public as required by law, and that the public notice of the time, place and purpose of the meeting was given as required by Vernon's Ann. Texas Government Code, Section 551.041, as amended;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Section 1. It is officially found and determined that said Election was duly ordered, that proper notice thereof was duly given, that proper Election officers were duly appointed prior to said Election, that said Election was duly and lawfully held, that due returns of the result of said Election have been made and delivered, and that this City Council has duly canvassed said returns, all in accordance with law and the Resolution calling said Election.
