SUBJECT: Written Resolution Awarding Bids for Purchase of Bulk Chemicals Used for Water and Wastewater Treatment Plants.

GENERAL INFORMATION

The City of Abilene Water Department is requesting that by written resolution the City Council award bids for the purchase of bulk chemicals to be used in water and wastewater treatment processes. Notices were published in the Abilene Reporter News on August 9th and 16th, 2015, and the bid opening date was August 25, 2015. The following table lists the individual chemicals bid, the staff recommended bidder, and the unit price for that bid.

SPECIAL CONSIDERATIONS

The following chemicals are used for the treatment of drinking water at the Grimes, Northeast, and Hargesheimer Water Treatment Plants, and/or for the treatment of wastewater at the Hamby Wastewater Treatment Plant. Bulk Chemicals for the Possum Kingdom Raw Water Roughing Facility are solicited separately, and a separate agenda item will be presented to the Abilene City Council at a later date.

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AWARDING BID TO VARIOUS VENDORS FOR THE PURCHASE OF BULK CHEMICALS USED FOR WATER AND WASTEWATER TREATMENT PROCESSES.

WHEREAS, The City of Abilene (City) owns and operates the Grimes, Northeast, and Hargesheimer Water Treatment Plants (WTPs) and the Hamby Wastewater Treatment Plant (WWTP); and

WHEREAS, the WTPs and the WWTP utilize large quantities of chemicals in the respective treatment processes, and the chemicals are purchased in bulk quantities from various vendors based on the results of an annual bid solicitation process; and

WHEREAS, the American Water Works Association has developed standards that include detailed descriptions and uniform quality control parameters for most chemicals used in the treatment of water and wastewater, and City staff did reference each standard in preparing the specification packages used for soliciting bids for bulk chemicals; and

WHEREAS, City staff evaluated all bids for conformance with the specifications and to determine if any bid was subject to the 5% local vendor preference, and the following list identifies the recommended low bidder for each bulk chemical bid item:
