1. **CALL THE MEETING TO ORDER:** President Dave Copeland called the meeting to order at 1:32 p.m. at Abilene Laboratories, 1325 Pine St., Abilene Texas.

- 2. APPROVAL OF MINUTES FROM THE SEPTEMBER 23, 2014, BOARD MEETING: John Beckham moved to approve the minutes from the September 23, 2014 board meeting. Dani Ramsey seconded and the motion carried.
- 3. SALES TAX REPORT FOR OCTOBER 2014: Mindy Patterson, Director of Finance for the City of Abilene, presented the Sales Tax Report for October 2014. The sales tax rebate for economic development is \$868,660, which represents August sales. This is 6.57% above last year and 4.48% above the projected FY 15 budget amount.
- FY15 FUNDING: Dr. Michael Sanders of TMAC presented a newly expanded program to the Board. TMAC has been delivering hands-on technical assistance and training to improve business' efficiency, productivity, growth, and sustainability for more than 18 years. Dr. Sanders explained that in the new program TMAC will be spending more time onsite to assist companies, rather than their typical 2-day onsite training and 90-day offsite support. By spending more time onsite TMAC will be able to assist clients begin their transition and build trust with them. Andrew Harmon of Clavel Corporation attended the Board meeting and testified to how TMAC helped his company and to the importance of TMAC's presence onsite.

Dr. Sanders requested that the Board consider increasing assistance from \$11,000 per company to \$25,000 per company in FY15 for TMAC's expanded program.
