 - a. **BA-2018-04:** A public hearing to consider a request from Robert Prichard/ eHT (Agent) for Brandon Beck (Owner) for a 17' Variance to the required 30' required front building setback in General Commercial (GC) zoning. Legal descriptions being Lots 4-7, Block E, B F Horn Subdivision of HARRIS, in City of Abilene, Taylor County, Texas and located at 3126 & 3102 S 14th Street.
 - b. **BA-2018-05:** A public hearing to consider a request from WesTex Towers Inc, agent Rodney Amonett for a variance to the height limitation on a structure that would penetrate a 100-to-one slope from any point on a runway, in relation to the airport runway at Dyess Air Force Base (AFB). The proposed structure (telecommunication tower) is planned on property located on the east side of Highway 83-84, extending approximately 1545' north from the intersection of County Road 149 and Highway 83-84.  - d. **BA-2018-08:** A public hearing to consider a request from Anthony D & Adalia Maun Hanna (Homeowner) for a Special Exception to locate a carport in the front building setback in RS-6 (Residential Single-Family) zoning. Legal description being SOUTHERN SANDS ADDN SEC 1 CONT 1, BLOCK 6, LOT 10, in City of Abilene, Taylor County, Texas and located at located at 5117 Twilight Tr.


