Mr. Steve Butman called the meeting to order at 4:00 P.M. and declared a quorum present and read the opening statement.

Minutes of the January 28th, 2014 meeting were submitted for approval.

Mr. Calk made a motion to accept the minutes with an amendment to be made to a vote: 450-462 Peach Street to keep on the Historic List of Properties: 3- Yes 2- No 1- Abstention, Mr. Miller seconded the motion. – The motion to approve as amended was approved unanimously.

Mrs. Stephanie Goodrich presented the staff report for HPT-0114, 842 Amarillo Street. Public hearing, discussion and possible approval of an application for Historic Project Tax Reduction submitted by Bill & Roxy Cox, for new fencing at the residential property located at 842 Amarillo Street.

The Jones/Behrens house is contributing house in the Sayles Boulevard National Register Historic District. It was built with an irregular from and has classical details such as Tuscan columns and a main entry with sidelights and multi pane transom windows. 9/9 windows on the front facade are also indicative of Classical Revival. The property was granted Historic Overlay Zoning in 1996.

The total cost of the project is \$11,026.43.

SPECIAL CONSIDERATIONS: In November 2013, the Landmarks Commission approved CA-2013-08, for a replacement fence. The work was carried out as approved.

STAFF RECOMMENDATION: approval as requested.

Mr. Butman opened the public hearing.

Mr. Bill Cox (applicant), Stated the newly constructed fence is a pleasing improvement to the property and maintains the historic look. Frontier Fence Company constructed the fence and was the least expensive estimate given.

Mr. Butman closed the public hearing.

Mr. McClellan made a motion to approve HPT-0114 Mr. Minter seconded the motion. The vote was unanimous (5-0).
