CALL TO ORDER

AGENDA ITEMS

HOZ-2019-01 A request initiated by the City of Abilene to remove Historic Overlay Zoning on the property located at 782 Palm Street known as the Hargrove House, which was built in 1909.

Mr. Zack Rainbow presented this request. The City of Abilene is initiating the request to remove Historic Overlay Zoning on the property. The house has been under condemnation by the Board of Building Standards since November 2007. The opinion of City Staff is disrepair to this building has reached a point that any remedy to the building will result in a loss of any original historic character.

Mr. Butman opened the public hearing. Seeing no one present and desiring to be heard, the public hearing was closed.

PLANNING STAFF RECOMMENDATION: Staff recommends approval.

Commission and Staff discussion included: 1) Clarification of ownership, progress and benefits received, and explanation of process and timeline if removal of overlay is approved

Ms. Lee made the motion to table this request until a meeting with the current owner could be initiated by the Southside Committee. Dr. McClellan seconded the motion. The motion to table this request prevailed by the following vote:

Discussion: Receive a Report, Hold a Discussion, and Take Action, Including Initiation of Historic Overlay Zoning regarding a Demolition Permit for a property listed as a "high priority" on Abilene Register of Historic Properties, per Section 2.3.4.4(h)(1) of the Land Development Code located at 2158 S. 3rd Street

Mr. Zack Rainbow announced a demolition permit had been received. The building was built in 1910. A discussion is required to learn the appropriate route the Commission would prefer Staff take with this request.

Historical significance is found in the biography of Mr. Howard Green, who lived at this address while attending high school in Abilene. He graduated from McMurray, became a sportswriter for the Abilene Reporter-News, and served in World War II. His grandson is Ethan Hawke, an actor.
