AGENDA ITEMS

Receive a Report, Hold a Discussion, and Take Possible Action, Including Initiation of Historic Overlay Zoning regarding a Demolition Permit for a property listed as a "high priority" on National Register of Historic Properties, per Section 2.3.4.4(h)(1) of the Land Development Code; Property known as Abilene Courts and located at 633 S. 11th Street

Mr. Zack Rainbow presented this item. This property is an active case with the Board of Building Standards. It was a motel/tourist court used as a motel and apartment building until it became

vacant and in disrepair. The subject address is not in Historic Overlay District (HO), but it is individually listed on the National Register of Historic Places.

Ms. Dalzell opened the public hearing. Seeing no one present and desiring to speak, the public hearing was closed.

Discussion among City Staff and Commissioners included: 1) The influence and historical significance of property being built after the Bankhead Highway and 2) the new Texas House Bill 2496 passed in May "relating to the designation of a property as a historic landmark by a municipality

As this was a discussion item, no action was taken. The Commissioners agreed it was not necessary to delay this process.
