# **Entrance Landscaping**

Master Plan – Under way and continuing.

**Security System Upgrade** – Substantially complete in warrantee phase.

**Taxiways Sealcoat Rehab** – After the first of the year sealing will begin. In April/May markings will be removed, additional seal coat work will be performed, then they will restore markings. This project is not time critical.

# **5.** Remove From table - Discussion and vote to recommend approval of the Escalator Replacement Contract

Motion made to remove this item from the table made by Mrs. Kean and Mr. Williams. Approved.

The Elevator bids came in higher than budgeted. Lowest bid came in at \$756,000 with a year of work required.

Recommendation was made by staff to scrap the elevator project. It will cost approximately \$200,000 to repair the escalators. Schindler says the escalators are rated for outdoors, however some other companies have expressed concern in the past. For \$756,000 with \$200,000 in repairs, the Airport can get a top of the line yearly maintenance contract for 10 years. The escalator replacement project can be added into the Airport Improvement Program as a project approximately 10 years later. At that point an FAA Grant could pay to replace the escalator with an elevator.

The maintenance agreement will be put out for bids and will include interior escalators. This repair will take less time than a complete elevator replacement. The maintenance contract

# 5. Executive Session:

Pursuant to Govt. Additionally, Section 551.076 provides that a governmental body may conduct a closed meeting to deliberate the deployment, or specific occasions for implementation, of security personnel or devices; or a security audit. After discussion in executive session, any action or vote will be taken in public.
