In accordance with section 418.016 of the Texas Government Code, on March 16, 2020, the Governor suspended various provisions that require government officials and members of the public to be physically present at a specified meeting location. The temporary suspension will allow for telephonic or videoconference meetings of government bodies that are accessible to the public, but leaves certain open-meeting requirements in place:

- Members of the public will be entitled to participate and address the governmental body during any telephonic or videoconference meeting;
- To hold a telephonic or videoconference meeting, a governmental body must post
  a written notice that gives the public a way to participate remotely, such as a tollfree
  dial-in number, and that includes an electronic copy of any agenda packet that
  officials will consider at the meeting;
- A governmental body must provide the public with access to a recording of any telephonic or videoconference meeting.

# 21.06.01. Invocation/Quorum/Recognition of Guests

Ms. Moore, Vice-Chair called the meeting to order at 5:21 p.m. She stated that a quorum of eight (8) Board members was present. Mrs. Plumlee then delivered the invocation.

#### 21.06.02. Citizens Comments

There were no citizens' comments.

### 21.06.03. Training Info/Presentation – ECI Overview

Mrs. White presented an overview of services provided by ECI (Early Childhood Intervention). ECI is a coordinated system of services and supports for Texas families who have children, birth to age 3, with delays in development, atypical development or disabilities. Families are expected to be active partners in their child's service delivery and to integrate activities into their daily routine. There are 3 ways for ECI eligibility – Developmental Delay (25% delay in any one of five developmental areas or 33% delay in Expressive Language if that is the only delay; Medical Diagnosis (ECI provides a list of qualifying diagnoses): Qualitative Determination of Delay (HELP Strands, LHPH determination, intelligibility, oral motor, hyper or hypotonicity, autism characteristics).

An Individualized Family Service Plan (IFSP) is developed for each client to determine: what services are needed: how often and where those services will be provided; who will provide the services; goals for the child and family; activities the caregiver can do every day to help the child reach their identified goals, what the child's current needs and strengths are and when services will be begin and end. Services are provided in the child's natural setting whether that be in the home, daycare, park, etc.

Delivered services include: Speech Language Therapy, Developmental Services SST, Physical Therapy, Occupational Therapy and Service Coordination. A transition plan is developed when the child reaches 27 months of age. Review plan allows changes and/or to meet with different programs to see which best meets the child's needs. The family will make their referral decision.

Many families do not pay for ECI services. Other pay based on a sliding fee scale called Family Cost Share. Referrals may be made by anyone. There is no diagnosis necessary, no prior screening or assessment, insurance is not required and assessments are done at no cost to the family

- 2626 Construction Update The start date on the construction was adjusted to provide time for an asbestos inspection. Date will be announced soon.
- CAC/Adaptive Recreation Discussion Mrs. Farrar stated that results
  of a survey to private providers show there is interest in re-opening
  Adaptive Recreation. BHC is in discussion with the City of Abilene
  about taking over this program. The City would lease a facility to us,
  as there would be such an increase in participants that there would not
  be adequate space at CAC. Additional staff would be needed.
  Discussions will continue.
- 1115 Extension Request Approved. New Uncompensated Care Pool Mrs. Goode said the Center for Medicaid and Medicare approved Texas's 1115 waiver extension for 10 years. There is also an uncompensated care pool (Public Health Provider Charity Care Pool or PHPCCP) being developed, which will start in the fall of 2021. It allows some reimbursement for delivering a service to folks who are indigent. The new PHPCCP, along with a directed payment program for Medicaid recipients, there is less concern about the DRIP program ending in 2021.
- Staff & COVID 19 Vaccine Mr. Jones stated there have been 210 employees that have been monitored for COVID/exposure. Some of those are repeats. There were 266 clients that were monitored. Staff were provided the opportunity to use emergency leave instead of using PTO for COVID issues. Mrs. Goode sent out a survey to see if staff had interest in receiving the vaccine. There were 132 employees that said they wanted the vaccine and have started receiving through the health department.

Community and/or Staff Meetings for the CEO – Mrs. Goode provided a review of the meetings that she and executive staff attended for the month.
