- 1. The meeting was called to order by Steve Ellinger, Chairman, at approximately 8:16 a.m.
- 2. Mr. Ellinger said the first order of business was the review and approval of the minutes of the February 3, 2009 meeting. David Beard made a motion to approve the minutes as written. The motion was seconded by Pamela Yungblbut and unanimously passed.

3. <u>CASES FOR REHABILITATION OR DEMOLITION:</u>

James Prescott, Code Enforcement Officer, then rearranged the order in which the cases were to be heard by the Board to accommodate the citizens and/or owners in attendance waiting to speak about the properties they were interested in.

Mr. Prescott stated there has been some painting and wood replaced. The back door is unsecured. Since the last time this property was before the board David Davilla had submitted a plan of action; the only open building permit is in the name of Virginia Lara, the previous owner. It appears the property has gone back to Virginia Lara. There has been no written request from the owner. The staff recommendation is 30 days to obtain all necessary permits or demolish the structure. Virginia Lara addressed the board stating she has owned the property the past twenty some years. She would like more time to try and sell it. Randy Halstead made the motion to grant 30 days to obtain all necessary permits, if that is not done demolish the structure, there was no second. Following further discussion Pamela Yungblut made the motion to grant 30 days for all necessary permits, or sell the property. The motion was seconded by Vanessa Faz, the motion was approved with Randy Halstead voting no.

Staff recommendation is 30 days to obtain a plumbing permit, if done grant an additional 30 days for rough in inspections and if this is done an additional 60 days to complete. The owner, Mike Aguirres, addressed the board stating they are working on the property trying to get it done; the timeframe recommended by staff is workable. Vanessa Faz made the motion to grant 30 days to obtain plumbing permit, and if this is done, grant an additional 30 days for all necessary rough-in inspections, and if this is done grant an additional 60 days to complete repairs. Mr. Prescott stated there continues to be rotted wood, damaged roof, illegal wiring, broken windows, and plumbing issues at this property. There have been no permits pulled since the initial condemnation; there has been a request from a representative of the owner for 180 days. Staff recommendation is 30 days to submit a plan of action with written cost estimates, if this is done, 60 days to obtain all necessary permits and rough-in inspections, and if this is done 60 days to complete repairs. Michelle Weaver, representative for the owner, addressed the board stating she has contacted 2 electricians and 2 plumbers but has to wait for money. Mr. Tennial is due to be released in May. David Beard made the motion to grant 60 days to provide a plan of action with written cost estimates, and if this is done, grant 60 days to obtain all necessary permits and rough-in inspections, and if this is done grant 60 days to complete the repairs. There is an open building permit, no inspections have been requested. The owner is requesting 180 days to complete repairs. Staff recommendation is to grant 60 days to obtain a framing inspection, and if this is done an additional 60 days to complete. Alvan McCutchen, representative for the owner addressed the board, before the property was condemned he had planned to replace the roof. The weather has contributed to the delay in finishing. Lydia Long addressed the board stating she owns the property behind this address and that the property is littered with trash and debris. She expressed concerns that the property continues to deteriorate. David Beard made the motion to grant the owner 60 days to obtain a framing inspections, and if this is done grant an additional 60 days to complete. The motion was seconded by Matt Loudermilk and unanimously carried.

Arlene Shivers, neighbor of the property, addressed the board stating her concerns regarding the property; she is in agreement with the staff recommendation. Lydia Long also addressed the board expressing her concerns regarding the property. Matt Loudermilk made the motion to grant 30 days to obtain a building permit or demolish the structure. She has contacted a plumber and electrician but the weather has been a detriment. Staff recommendation is to grant 30 days to submit a plan of action with written cost estimates or demolish the structure.
