The meeting was called to order at 7:19 A.M. by ATCCAC Advisory Board Chair Dee Moore. Board minutes from the previous meeting of 011/20/12 were reviewed. Ernest Slatinsky motioned that the minutes be approved. The motion was seconded and the minutes were approved as written.

## New Business

Melinda Beard began the meeting with a PowerPoint Presentation titled, It Takes a Team. The presentation outlined the ties that all of the MDT members make when working together as a team, resulting in better services across the board. MDT members include but are not limited to the kids, school/daycare, medical, CAC, law enforcement, CPS, family/friends, mental health, and prosecution.

Melinda then began to discuss the case of Lacy Wright (child's mother) and her boyfriend Daniel Crippen who was charged and convicted of aggravated sexual assault of a child. Daniel Crippen's trial began in 2011. Lacy Wright's trail began in November of 2012 and she was charged with injury to a child. After the details of the case were shared with the group, board members expressed their unbelief and appreciation for all that the CAC, law enforcement, prosecution, RVCC, CPS, and so many others contribute to putting these criminals away.

## **Director's Report**

Melinda Beard advised that CAC of Texas offers board training. If anyone is interested, they can contact Melinda for more information. Melinda asked if there were any questions regarding the CAC report that was sent out prior to the meeting. Several people expressed their opinion and appreciation for all the CAC staff has done to improve the services provided to the community.

The press conference was held at the Taylor County Law Enforcement Center on the 2<sup>nd</sup> floor. Chief Standridge invited all CAC board members to come show support if possible. It was also announced that April is Child Abuse Awareness month and plans and ideas need to be getting put together in order to make it big and get awareness out to the community.
