- a. Discussion and possible vote to approve Auditorium Beverage Policy: Ms. Moser stated that promoters and patrons have requested for beverages to be allowed in the auditorium. In 1985, City Council approved alcohol at the Abilene Convention Center with the exception of the auditorium area. Currently, no food or beverages are allowed in the auditorium. Ms. Moser updated the board on current policy issues. One major issue is that we must remain competitive with other venues. Molly stated that staff completed a city comparison survey, which showed all cities are serving, or in the process of serving, alcohol in their auditoriums. Ms. Moser proposed the following be approved: 1) Allow beverages in the auditorium, 2) All beverages to be served in a spill-proof souvenir cup, 3) Submit a request for proposal for a one-year agreement with one vendor to service auditorium events. There being no further discussion, Mr. Iziar Lankford made the motion to approve beverages in the auditorium. Mr. Clint Rosenbaum seconded the motion. The motion was approved by all members, with the exception of Mr. Joe Alcorta, who voted against. City Council will need to take final action on this item.
- **b.** Discussion and possible vote to approve funding for rental of Convention Center Christmas Tree: Ms. Moser stated that it was time, again, to discuss funding for the Convention Center Christmas Tree. Ms.

Moser reiterated that the price would remain the same, \$4,000, and includes the set-up, decorations, teardown and removal. After a brief discussion, Mr. Joe Alcorta made the motion to approve the funds for the Christmas tree. The motion was seconded by Mr. Shaun Martin and approved by all members present.

c. Facility Improvements Update: Ms. Molly Moser briefed the Board on updates that had taken place in the facility. The auditorium sound system and acoustical treatment was completed in August. patrons regarding the new sound system. New lighting and ceiling tiles have been installed in the Greenroom. In the next few months the steps on the north side of the building would be demoed. We are working with Tim McCarty to redesign the north plaza. After a brief discussion, Mr. Clint Rosenbaum motioned that all outside steps be re-done and LED lights be installed for better lighting. The motion was second by Mr. Tom Boecking and approved by all members present.
