Tony Neitzler, Assistant Director of Planning & Community Development, said that since this is a relatively undeveloped area of the City (in the area of Bumper Gate Road), and since it is one of the major approaches to the City, it was recommended by the Planning & Zoning Commission that a study be developed called the Bumper Gate Road Land Use Study.

Carol Foy, Planner, presented the characteristics to the area and said that the study comprises approximately 1,290.5 acres or about 2.02 square miles, located in the westernmost part of the city, immediately adjacent to the Tye city limits. Study area boundaries are the Tye city limits to the west, and Fulwiler Road on the east. North and South boundaries are north section of Fulwiler Road and U. S. Hwy.80 respectively. She pointed out that this area is bounded by the Dyess study area to the south.

After discussion, Councilman Higginbotham moved approval of the Bumper Gate Road Land Use Study, to he used as a guideline for the Council in making decisions in the area. The motion was seconded by Councilman Scott. The motion carried as follows:

POLICE TRAINING ROOM CITY HALL, THE CITY OF ABILENE, TEXAS.

The City Council of the City of Abilene, Texas, met in Work Session, Thursday, December 4, 1980, at 11:00 a.m. with Mayor Oliver Howard, present and presiding. Councilmen Seaton Higginbotham, Leo F. Scott, S.M. Moore, Jr. L. D. Hilton & Councilwoman Kathy Webster, present. Councilman Dick Bowen absent. City Manager Ed Seegmiller, Assistant City Attorney Gary Landers, & City Secretary Ruth Hodgin, present.

Senator Grant Jones, Representative Walter Grubbs, Representative Gary Thompson, District Judge J. Neil Daniel, and other City Administrators were also present. Dr. Thompson's Public Administration Class from Abilene Christian University was also present.

Dr. Thompson said that he felt that since crime was on an increase, the City of Abilene was doing good in looking at it before it becomes a crisis. He introduced Dr. David McKenna, Professor of Criminal Justice at the University of Texas, at Arlington.

Dr. McKenna, in his presentation, showed the rise of crime here, state-wide and nationally. The City of Abilene's crime rate has increased greatly, by 163%, while crime has increased nationwide by 39%. Although the percentage is high, the City of Abilene still has one of the lowest crime rates in the nation.

Dr. McKenna said that a steep upward crime trend began in the late 1950s, but the statistics were ignored for many years by Americans who believed that the news media fabricated the figures for sensational value or that improved police reporting methods accounted for the hike. He said that more people are believing what he feels are actually conservative estimates of criminal activity now, he thought.

pr. McKenna/that the FBI Uniform Crime Report statistics show 34.7% more burglaries committed in Abilene in 1980, and 66% more murders/non-negligent homicides this year than last. This is cause for concern and he commended the Administration, in trying to find a way to control crime more effectively, within the City.

Dr. McKenna brought out several ways that other cities are trying to prevent crime. He pointed out that the Police Department should have a Crime Analysis Program, and use the data which is collected in helping decrease crimes within the City.

Dr. McKenna discussed other cities crime prevention methods, some of which are distribution of crime prevention pamphlets, property identification programs, media crime warnings, nosy neighbors block watchers and citizen cooperation in alerting police to suspicious activity.

It was noted that the City of Abilene is already doing some of the things which were mentioned to deter crime within the City.

The Council discussed several ways in which they felt that it would help in control of burglaries within the City.

Mr. Seegmiller said that he felt that some way of involving the community would be the best way of helping control crime. He also brought out that higher budgeting in the police department was not the answer, in his opinion. He brought out performance as the answer to better police protection.

It was brought out that in trying to deter crime, officials also should study what happens to criminals after they have been apprehended. Frequent plea bargains or light jail sentences can contribute to rising crime.

Many crimes are committed by 14 to 25 year old people, Dr. McKenna said and officials agreed that Juvenile crime should be better addressed in Abilene.

Dr. McKenna said that some cities have enlisted the help of Citizens Band Radio Clubs, taxicab operators, bus drivers, and others in using their radios to alert police when they see something suspicious going on.

After much discussion, it was decided that there would be another meeting in a few months to bring the Council up to date on what is being done to lower the crime rate in the City.

There being no further business, Mayor Howard adjourned the meeting at 1:00~p.m.
