The City Council of the City of Abilene, Texas, met in Regular Session, Thursday, January 8, 1981, at 9:00 a.m. with Mayor Pro Tempore S.M. Moore, Jr. present and presiding. Mayor Oliver Howard absent. Councilmen Seaton Higginbotham, Dick Bowen, Leo F. Scott, L.D. Hilton & Councilwoman Kathy Webster, present. Assistant City Manager Curtis Hawk, City Attorney Harvey Cargill & City Secretary Ruth Hodgin, present.

Minutes of the last Regular Meeting held December 18, and the Special Workshop held December 11, 1980, were approved as written.

Dwayne Hargesheimer, Director of Utilities, said that the Staff was recommending that the bid of Panhandle Construction Co. for construction of water distribution system feeder mains be approved, even though the bonds had not been sold for the funding of the project.

WATER MAINS AWARD CONTRACT-CONSTRUCTION OF WATER DIST-RIBUTION FEEDER MAINS

Roy McDaniel, Director of Finance, said that he was concerned about the two projects (construction of the water distribution feeder mains and the Abilene Water Treatment Plant Renovation). He pointed out that financially the water distribution system feeder main project could be funded, and surely the City would be able to sell some of the bonds by late spring.

After discussion, Councilman Hilton moved adoption of the resolution awarding a contract for the Water Distribution System Feeder Mains in the amount of \$484,578.00, to Panhandle Construction Co. The motion was seconded by Councilman Higginbotham. The motion carried as follows:

Mr. Hargesheimer said that there was not enough money to do the Abilene Treat Plant Renovation without selling some bonds, so the Staff was recommending that the bids for the project be rejected at the present time.

Mr. John Cook, Freeze & Nichols, explained that the renovation project to the treatment plant could be postposed for 6 months to two years, but it would have to be done in order for the City to treat enough water for the growing population. He said that his Staff was looking into any way the city could save money when they advertise for bids for this project again. He assured the Council that the project was justified and should be done as soon as bonds could be sold to finance the project.

After discussion, Councilwoman Webster moved to reject the bids for the renovation of the Abilene Treatment Plant. The motion was seconded by Councilman Scott. The motion carried as follows:

Bob Whitehead, Director of Public Works, presented a request to advertise for street improvements, Antilley Road, from U.S. Hwy 83-84 to Buffalo Gap Road & Pine Street.

Mayor Moore asked Mr. Whitehead to present only Antilley Road at the present time and wait to present Pine Street at another date.

Mr. Whitehead explained that their plan requires a 64' street with paving & curb & gutter on both sides. He said that it would be necessary to approve a resolution declaring the need for paving and also authorize the advertisement for bids for such project.

After discussion, Councilman Bowen moved adoption of the resolution ordering the improvement of Antilley Road, from US 83-84 to Buffalo Gap Road & authorizing advertisement for hids for such project. The motion was seconded by Councilman Higginbotham. The motion carried as follows:

Curtis Hawk, Assistant City Manager, said that the Staff needed the Council's instruction on what to do on a problem at the Airport. He said that there was a need for the development of a Master Plan at the Airport, in order for the airport to be developed in an orderly fashion.

Glenn Meeks, Airport Manager, said that the 1966 Consultant's recommendations were not accepted by the then City Council. He pointed out that we needed a Master Plan for guidance in developing the Airport and the surrounding property.

Mr. Whitehead said that there had been a great deal of interest in developing the airport and the surrounding property but the Staff needed guidance from some trained professional people in how to develop it. He said that there was interest in using some of the land for industrial uses. He said that he had letters from 6 firms who were experienced planners in the area of airport planning.

After discussion, Councilman Bowen moved adoption of the resolution authorizing preparation of requests for proposals for an Airport Master Plan and authorizing the use of Community Development Block Grant Program Funds. The motion was seconded by Councilman Scott. The motion carried as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AUTHORIZING PREPARATION OF REQUESTS FOR PROPOSALS FOR AN AIRPORT MASTER PLAN AND AUTHORIZING THE USE OF COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FUNDS.

Mr. Whitehead explained that the Staff had been approached for a waiver of Subdivision Regulations concerning one lot on T & P Lane. He said that the street was a collector street & carried a lot of traffic. He pointed out that the Staff was recommending against the waiver.

Councilman Bowen moved to deny the waiver on T & P Lane of the Subdivision Regulations concerning curbing & guttering. The motion was seconded by Councilwoman Webster. The motion carried as follows:

Mr. Whitehead explained that the Staff had been approached for a waiver of the Subdivision Regulations concerning one lot on Maple Street. He said that the paving & curbing could be constructed now, without detriment to the existing paved surface. Therefore, the Staff was recommending against the waiver.

Councilwoman Webster moved to deny the waiver request on Maple Street of the Subdivision Regulations concerning curbing & guttering. The motion was seconded by Councilman Hilton. The motion carried as follows:

Wayne Herrington, Assistant Director of Planning & Community Development, said that Mrs. Clark has a contract to purchase a replacement house in the Goodlow Program, and the cost would be appriximately \$3,000 over the \$15,000 limit. He requested the Council to approve the replacement purchase.
