After discussion, Councilman Higginbotham moved to return the proposed ordinance reclassifying from RM-2 (Residential Multi-family) to LC (Limited Commercial) District, to the Planning & Zoning Commission for further consideration. The motion was seconded by Councilman Rodriguez. The motion carried as follows:

Bob Whitehead, Director of Public Works, discussed the need for the City to consider construction & maintenance agreement with the State Department of Highways & Public Transportation for bridge replacement on Rebecca Lane at Elm Creek. He said that it would only cost the City 20% of an estimated cost of \$149,000. He pointed REBECCA LANE out that the Staff is working presently with property owners on the AT ELM CREEK extension of Southwest Drive from Winters Freeway to Curry Lane, and a collector street from Curry Lane south to Rebecca Lane. Actual construction of the bridge will not begin for approximately eighteen (18) months. Therefore, the City & County will have time to work out and budget the local funding share.

BRIDGE-CONST. & MT. AGREEMENT

After discussion, Councilman Fogle moved adoption of the oral resolution authorizing the Mayor, on behalf of the City of Abilene, to enter into a"Construction and Maintenance Agreement for Bridge Replacement or Rehabilation Off the State System." The motion was seconded by Councilwoman Webster. The motion carried as follows:

AYES: Councilmen Higginbotham, Rodriguez, Fogle, Councilwoman Webster & Mayor Hall.

Arkie Pierce, Land Agent, said that they had made an offer to Mr. & Mrs. Thomas Clark for right-of-way required in the widening of Barrow Street and they had refused the offer. So therefore, the condemnation proceedings is the only choice that the City now has.

After discussion, Councilman Higginbotham moved adoption of the resolution declaring the necessity for acquiring by condemnation the fee simple title to certain described property for right-of-way purposes of the Barrow and South Mockingbird street widening and improvement project and ordering the condemnation of said property to proceed. The motion was seconded by Councilwoman Webster. The motion carried as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, DECLARING THE NECESSITY FOR ACQUIRING BY CONDEMNATION THE FEE SIMPLE TITLE TO CERTAIN DESCRIBED PROPERTY FOR RIGHT-OF-WAY PURPOSES OF THE BARROW AND SOUTH MOCKINGBIRD STREET-WIDENING AND IMPROVEMENT PROJECT, AND ORDERING THE CONDEMNATION OF SAID PROPERTY TO PROCEED.

Lee Roy George, Director of Planning & Community Development, presented the resolution establishing policy for decisions on growth in newly developing areas and providing for the use of certain municipal powers to implement these policies. He said that the Council had already adopted three policies recommended by the Strategies for Responsible Growth Committee on where and how to encourage growth.

Tony Neitzler, Assistant Director of Planning & Community Development explained that the first of the two policies that the Staff is asking the Council to adopt says "it is in the City's best interest to encourage development in areas adjacent to compatible development already receiving City services where those services have excess capacity.'

Mr. Neitzler explained that the second policy reads "it is in the City's best interest to discourage development in remote areas as well as those areas that exhibit environmental hazards."

After discussion, Mayor Hall said that he would like for the Staff to return the resolution for the Council's consideration, after POLICY FOR the Council has more time to study the item and when all the Council GROWTHis present if possible.

PLANNING-TABLED

Councilman Higginbotham moved to table the resolution considering the adoption of Strategies for Responsible Growth Policy. The motion was seconded by Councilman Rodriguez. The motion carried as follows:

AYES: Councilmen Higginbotham, Rodriguez, Fogle, Councilwoman Webster & Mayor Hall.

NAYS: None.

Mr. Whitehead presented the resolution abandoning two drainage EASEMENT easements. He said that the small existing channel easement to the RELEASEwest was to serve the culvert under F.M. 707. The State will retain ON FM 707maintenance responsibilities for F.M. 707, and the drainage ditches STATE OF TEXA in the right-of-way so the City Staff was recommending the abandon-

Mr. Whitehead said that the second easement extends along the Catclaw Creek channel. He pointed out that the South-Side Land Use Plan approved by the City Council provides for this area in the floodway to be park or open space. Therefore, the Staff recommended to retain this easement.

Councilman Higginbotham moved adoption of the resolution, only abandoning one easement (concerning F.M. 707), retaining the one along Catclaw Creek. The motion was seconded by Councilman Fogle. The motion carried as follows:

A RESOLUTION AUTHORIZING THE CITY OF ABILENE TO ENTER INTO A CONTRACT WITH THE STATE OF TEXAS WHEREBY THE CITY WILL ASSUME RESPONSIBILITIES FOR DRAINAGE AT Sta. 150+00 ON F.M. HIGHWAY 707 IN THE CITY OF ABILENE, TEXAS.

Wayne Kurfees, Director of Traffic & Transportation, explained that McDonald's resident manager, Mr. Bob Babbitt, has been on board since May 1 and is coordinating an orderly transition of responsibility. It is intended that the management firm will have full responsibility for running the transit system and maintaining the buses by early June. TRAFFIC-He said that they were recommending the lease of the old Firestone truck tire facility, which is located at the northeast corner of North FACILITIES 8th and Pine. The cost of the lease will be \$800 per month which the Land Agent feels is very reasonable.

LEASE OF FOR BUS SHOP

After discussion, Councilman Higginbotham moved to authorize the City Manager to enter into a one year lease for this facility with option to continue on a month-to-month basis until a permanent facility is ready. The motion was seconded by Councilwoman Webster The motion carried as follows:

Mr. Kurfees presented the new bus route & schedule, which a public hearing was held on May 13, at 10:00 a.m. These new routes & schedules are to become effective on June 15. He said they were basically the same as when they were presented to the Council in March, with a minor modification to provide shift change service to the State School as requested by the Council.

The motion was seconded by Councilman Higginbotham. The motion carried as follows:

AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS

Mr. George discussed the Urban Land Institute Panel Service, a group of professional leaders who will visit Abilene and develop recommendations on future development here. Revenue Sharing will be used for the \$50,000 project cost, Mr. George said.

PLANNING-URBAN LAND INSTITUTE PANEL SERVICE

Mr. George said that the above group, Urban Land Institute Panel Service, will be directing a panel study on four (4) major objectives which concern the future development of the City. The areas to be discussed are Industrial Potential, Central Business District Revitalization, Transportation Strategies in the Central Business District & Implementation of Strategies.

Throughout the week, the nine (9) member panel will draw on the expertise of selected Abilenians to evaluate the conditions of the City and make recommendations on the specific objectives. By Friday, June 5, 1981, the panel will have developed recommended strategies for the future development of the City.

The Council met in executive session to discuss personnel matters (concerning boards & commissions) and pending litigation. No action was taken when the Council reconvened in open session.
