He said that the street has never been opened on the ground or maintained by the City Street Department, but he said he can see no reason for it not being paved, so he recommends that the waiver be denied.

SUBDIVISION WAIVER-**FARRINGTON** MARKETING I DENTED

Councilwoman Webster moved to deny the request for a waiver from Farrington Marketing, Inc. for a waiver from paving requirements on Key Western Dr. west of Winters Freeway. The motion was seconded
