The City Council of the City of Abilene, Texas, met in a Pre-Council Work Session on April 11, 1985, at 8:30 A.M. in the Basement Conference Room of City Hall. Mayor David Stubbeman was present and presiding with Councilman Julian Bridges, Councilwoman Billye Proctor-Shaw, Councilmen Walter E. Wheat, A.E. Fogle, Jr., Welton Robinson and Harold Nixon. Also present were City Manager Jim C. Blagg, Assistant City Managers Roy L. McDaniel and Rick Childers, City Attorney Harvey Cargill, Jr., City Secretary Patricia Patton, and various members of the City Staff.

Mr. Rick Weatherl, Architect, gave the Council a brief review of the proposed new Fire Station #5 to be located at E. N. 16th and Pemelton.

The Council briefly discussed various consent and regular agenda items. There being no further questions, the meeting was recessed to the City Council Chambers for the Regular Council Meeting.

Mayor Stubbeman reconvened the City Council of the City of Abilene, Texas, into Regular Session April 11, 1985, at 9:00 a.m. in the City Council Chambers of City Hall.

Invocation was given by Councilman Harold Nixon.

The minutes of the Pre-Council Work Session and the Regular City Council Meeting held March 28, 1985, stand approved.

Patricia A. Patton, City Secretary, briefed the Council on an oral resolution to consider adopting a Records and Information Management Policy Statement. Approval of the policy is the first step in developing an overall program and it must be approved before further development can take place. The purpose of this policy is to establish the need for a program and assign responsibility for its development and implementation.

Councilwoman Proctor-Shaw moved to adopt the Records and Information Management Policy Statement, by oral resolution, as recommended by the staff. The motion was seconded by Councilman Nixon and the motion carried:

AYES: Councilman Bridges, Councilwoman Proctor-Shaw, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

Councilman Fogle moved to remove from the table a thoroughfare abandonment - TC-01985 - request near Industrial Boulevard and Woods Place. The motion was seconded by Councilman Bridges and the motion carried:

AYES: Councilman Bridges, Councilwoman Proctor-Shaw, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

Brad Stone, Principal Planner, briefed the Council on an ordinance on second and final reading being a thoroughfare abandonment request - TC-01985 - a request of H. M. Root (Representing Woods Psychiatric Institute) beginning at the south right-of-way line of Industrial Boulevard and extending south a distance of 580 feet. Staff recommends approval of the request subject to the following conditions being met:

1. Retention of the entire length and width of the street as an access and utility easement.
2. Resubdivision of adjoining land so that all lots front onto a publicly dedicated street.

The Planning & Zoning Commission also recommends approval of the request subject to the same conditions.

Although, a public hearing was held at a previous meeting, the Council felt it was important to hear comments on the request.

IN FAVOR:

- . Harry Root, representing Woods Psychiatric Institute, stated the primary purpose of the request is to improve security.
- . Burl Harris, office at 1358 Petroleum Drive, is interested in extending Energy Drive through Treadaway.
- . Jack Lytle, Vice President of City State Savings in San Angelo-Homestate Savings in Abilene, is in favor of the request since Burl Harris is considering extending Energy Drive.

The Council asked Mr. Root if he could replat this property and he stated that they could not at the present time because they have separate financing on the two pieces of property but they could replat in the future.

Councilman Fogle moved to approve a thoroughfare abandonment request - TC-01985 - beginning at the south right-of-way line of Industrial Boulevard and extending south a distance of 580 feet under the following conditions: 1. Retention of the entire length and width of the street as an access and utility easement. 2. That Woods Psychiatric Institute replat the aforementioned property in 15 years, when financing will be completed, or the thoroughfare would be reverted back to a public thoroughfare. The motion was seconded by Councilwoman Proctor-Shaw and the motion carried:

Bob Whitehead, Director of Public Works, briefed the Council on a resolution to consider the acquisition of approximately 66 acres adjacent to the Abilene Municipal Airport. He stated that land acquisition for Fixed Based Operation (FBO) is grant eligible (90% federal - 10% city). This particular area was selected due to its proximity to proposed future taxiways along the East side of Runway 17R-35L. There is a need to protect this area of the Airport for development in accordance with the recommendations of the Airport Master Plan. Staff feels since grant funds are available for this purpose it would be wise to use a portion of the current available allocation to proceed with the acquisition of this property. Staff recommends Council adopt the resolution authorizing the acquisition of said land.

Councilman Fogle moved to approve the resolution authorizing the acquisition of 66 acres adjacent to the Abilene Municipal Airport, as recommended by the staff. The motion was seconded by Councilman Nixon and the motion carried:

Bob Whitehead, Director of Public Works, briefed the Council on a resolution to consider approval of Drainage Standards as referenced in the Stormwater Management Ordinance. The establishment and use of the approved Drainage Standards is required by Section 23-264 of the Subdivision Regulations relative to Stormwater Management. A draft of the standards was presented to the Engineering and Development Community and reviewed thoroughly. There are some areas of disagreement in the standards, however, these standards are recommended as a beginning point. The Flood Hazard Technical Advisory Committee (Flood Tech Committee) also reviewed the draft and recommended some changes. The proposed standards before the Council include any recommendations made by the Flood Tech Committee. Staff recommends Council approve the proposed Drainage Standards, as adopted by the Flood Tech Committee.

David Todd, Engineer, stated that he just received a copy of the revised Standards yesterday and he requests that the Flood Hazard Technical Advisory Committee meet one more time.



John Burleson, Engineer, agreed with David Todd in that the Advisory Committee should meet again.

Councilman Robinson, moved to table the resolution approving Drainage Standards referenced in the Stormwater Management Ordinance until April 25, 1985, to allow the Flood Hazard Technical Advisory Committee to meet again and to call a public hearing for April 25, 1985. The motion was seconded by Councilman Nixon and the motion carried:
