Dwayne Pyburn, Assistant Chief of Police, briefed the Council on an oral resolution to consider renewal of the Wrecker Service Contract with O'Bar and Chittum Wrecker Service. David Weeks, Media Southwest, Inc., handed out copies of the recent citizen survey that has been completed and introduced Dr. Shipley, Shipley & Associates, Inc., who assisted in conducting the survey. He reviewed the results of the survey with the Council.

This report summarizes the results of the comprehensive survey of 412 registered voters in the City of Abilene, Texas, performed by Media Southwest, Inc., and Shipley & Associates, Inc., of Austin, Texas. Respondents were interviewed by telephone by the subsidiary field service -- Western Opinion Research -- of Shipley & Associates, Inc. The interview period was July 7 to 10, 1985. The poll was undertaken to provide an assessment of the current opinions of the Abilene electorate regarding municipal government, City services and problems facing the City. The questionnaire was designed to measure voters' opinions in these main areas:

- . Definition of major problems facing the City's government, as by respondents in an open ended (non-prompted) format;
- . Overall views of various City departments;
- . Rating of selected City services;
- . Generalized questions about the quality of life in Abilene;
- . Demographic data regarding the respondents.

No action taken.

Terry Meza, Executive Director of the Abilene Economic Development Company, Inc., briefed the Council on an oral resolution to consider Abilene Economic Development Company's Annual Budget for FY1986. She briefly reviewed the budget and explained that in addition to the normal Community Development Block Grant Funding, the County approved \$5,000 to provide business assistance to those people who live outside the city limits. Additionally, she reviewed with the Council the Abilene Economic Development Company, Inc., annual report of activities for 1985.
