The City Council of the City of Abilene, Texas, met for a Special Council Meeting on September 27, 1985, at 9:00 A.M. in the Council Chambers of City Hall. Mayor Pro Tempore Harold Nixon was present and presiding with Councilman Gary D. McCaleb, Councilwoman Betty Ray, Councilmen A. E. Fogle, Jr., and Welton Robinson. Mayor David Stubbeman and Councilman Walter E. Wheat were absent. Also present were City Manager Jim C. Blagg, Assistant City Managers Roy L. McDaniel and Rickey Childers, City Attorney Harvey Cargill, Jr., City Secretary Patricia Patton, and various members of the City Staff.

Invocation was given by Councilman Gary McCaleb.

Lee Roy George, Director of Planning, gave a briefing on the East Abilene Annexation and stated that the first reading of the annexation ordinance will be held on October 24, 1985, during the City Council meeting. The second and final reading of the ordinance will be held December 5th also during the City Council Meeting. He also stated that the service plan and the legal description may be reviewed in the City Secretary's Office during working hours.


Mayor Nixon opened a public hearing for the purpose of considering the East Area Annexation and the following people spoke in opposition to the request:


