Mayor David Stubbeman was present and presiding with Councilman Gary D. McCaleb, Councilwoman Betty Ray, Councilmen Walter E. Wheat, A. E. Fogle, Jr., Welton Robinson, and Harold Nixon. Mayor Stubbeman removed item 5a, which is an ordinance on first reading annexing certain property, from the consent agenda to be considered separately.

Councilman Fogle moved to approve the consent agenda items being 5b, 5c, 6a and 6b, as presented by the staff. The motion was seconded by Councilwoman Ray and the motion carried:

AYES: Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

Lee Roy George, Director of Planning, briefed the Council on an ordinance on first reading to annex into the City of Abilene certain properties adjacent to the eastern City limits in the vicinity of F.M. 18 and Elmdale Road, including approximately 2.4 square miles (and labeled as Alternate B). Mr. George stated that the action necessary today was to approve the annexation ordinance on first reading and set a public hearing for December 5, 1985.

Councilman Nixon made several comments regarding the annexation. He stated that the record shows that at the previously held public meetings, all property owners, with the exception of one, are in opposition to annexation; there is a lack of preceived benefits to property owners; and there is concern of a possible negative impact on the Hamby Water Supply Corporation. Councilman Nixon's points of concern are: property owner opposition; that a previous Council authorized these water lines that are outside the City limits; all the citizens are already being served water service by either Abilene, Potosi, or Hamby; the Fire Department already provides fire protection in the area; testimony indicates that the County can better maintain the roads in the area; ninety percent of the area is agricultural use; there is no evidence of major development at this time in the area; that the City is facing major water funding projects immediately; and where would the revenues for this annexation come from?

Therefore, Councilman Nixon moved to DISAPPROVE the ordinance annexing property in east Abilene. The motion was seconded by Councilman Robinson.

Mayor Stubbeman stated that his primary desire is to annex into the City the water and sewer lines that are owned by the City. Councilman Fogle stated that there are several considerations taken into account when annexing property—one being the interest of the City. He feels there is major development in the area and that this area is one of the major entrances to the City. It is his opinion that the Council needs to consider some portion of this area for annexation and that the Council would not be representing the best interest of the City if they did not.

The motion was voted on and the motion FAILED:

AYES: Councilman Wheat, Robinson and Nixon.

NAYS: Councilman McCaleb, Councilwoman Ray, Councilman Fogle and Mayor Stubbeman.

Councilman Nixon moved to annex the Craft property (#21) only, since he was the only property owner that publicly favored annexation. The motion was seconded by Councilman Robinson and the motion FAILED:

AYES: Councilman Wheat, Robinson and Nixon.

NAYS: Councilman McCaleb, Councilwoman Ray, Councilman Fogle and Mayor Stubbeman.

Councilman Fogle stated that he agreed with Councilman Nixon in the regard that the City does not need to annex farm and ranch land or undeveloped land, and to eliminate that land from the annexation would be satisfactory to him. Therefore, Councilman Fogle moved to exclude from annexation the following properties: #7, 8, 9, 38, 38a, 39, 40, 41, 94, 98, 99, 100, 100a, 103, 104, 105a and portions of 105 and 106. The motion was seconded by Councilwoman Ray.

Councilman Nixon proposed an amendment to Councilman Fogle's motion which would additionally eliminate the following properties: #1, 1a, 2, 2a, 3, 4, 5, and 42 through 78 inclusive. This would eliminate those property owners on the Hamby Water Supply Corporation's System. The amendment was seconded by Councilman Wheat and FAILED:

The Planning & Zoning Commission and the staff recommend disapproval of the request.

Mayor Stubbeman opened a public hearing for the purpose of considering the aforementioned item and the following persons spoke in favor of the request:

Lee Roy George, Director of Planning, briefed the Council on a request to consider the extension of sign control into the Extraterritorial Jurisdiction. The Planning & Zoning Commission's Subcommittee on Sign Regulations recommends that the City not extend the proposed new regulations into the extraterritory. The Staff

concurs with the Subcommittee's recommendation and recommends the City Council decline the extension of sign controls outside City limits and rely upon the State Department of Highways and Public Transportation to exercise the restrictions found in H.B. 1330.

Councilman Fogle moved to DENY the extension of the City's sign regulations into the extraterritorial jurisdiction, as recommended by the staff. The motion was seconded by Councilwoman Ray and the motion carried:

AYES: Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

NAYS: None.

Sandra Trosky, Assistant Land Agent, briefed the Council on an oral Resolution for Oil & Gas Drilling Permit #8507, from Oilwell Operators, Inc., located West of the Abilene Municipal Airport, out of the North 1/2 of Section 61, Blind Asylum Lands, Taylor County Texas. The drill site in located within the City limits and on private property and is not within the floodplain. Staff recommends approval of the permit.

Mayor Stubbeman opened a public hearing for the purpose of considering the aforementioned item and there being no one present and desiring to be heard the public hearing was closed.

Councilwoman Ray moved approval of the oral resolution for Oil & Gas Drilling Permit #8507, from Oilwell Operators, Inc., as recommended by the staff. The motion was seconded by Councilman Wheat and the motion carried:

AYES: Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

Roy McDaniel, Assistant City Manager, briefed the Council on a resolution Supporting and Endorsing the Approval of Constitutional Amendments One and Two. He explained that Amendment Number One provides funding mechanisms for certain types of projects that cities might qualify for. Amendment Number Two provides for the sale of bonds to create an agricultural water conservation program. While neither of these amendments may directly benefit the City of Abilene anytime in the near future, the staff feels that they are important as a first step toward establishing a statewide water

Councilman Robinson moved to adopt the resolution approving Constitutional Amendments Number One and Two, as recommended by the staff. The motion was seconded by Councilman Nixon and the motion

Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, AYES: Fogle, Robinson, Nixon and Mayor Stubbeman.

NAYS: None.

The resolution is numbered 102-1985 and is captioned as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, SUPPORTING AND ENDORSING THE APPROVAL CONSTITUTIONAL AMENDMENTS ONE AND TWO.

Bob Whitehead, Director of Public Works, briefed the Council on a Resolution to consider funding for Curry Lane Bridge. Staff recommends the City Council authorize the Mayor to sign the resolution and to place the City's share of this project (\$193,304) in escrow with the State.

Councilman Nixon moved to approve the resolution adjusting the funding level for the City in its participation in this program and placing the City's share in escrow with the State. The motion was seconded by Councilman McCaleb and the motion carried:

AYES: Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman. NAYS: None.

The resolution is numbered 103-1985 and is captioned as follows:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, ADJUSTING THE FUNDING LEVEL FOR THE CITY IN ITS PARTICIPATION IN THE FEDERAL OFF-SYSTEM BRIDGE REPLACEMENT PROGRAM.

Sandra Trosky, Assistant Land Agent, briefed the Council on Oil & Gas Lease #1985-03, being 163 acres of SE 1/4 of Section 52, Block 14, T & P RR Co. Survey, Jones County, Texas, which is a part of the City's New Sewer Farm. She stated that one bid was received and staff is recommending the Council award the lease to Chalmers Operating Company, Inc.

Mayor Stubbeman opened a public hearing for the purpose of considering the aforementioned item and there being no one present and desiring to be heard the public hearing was closed.

Councilman Fogle moved to award the bid for Oil & Gas Lease #1985-03, to Chalmers Operating Company, Inc., as recommended by the staff. The motion was seconded by Councilwoman Ray and the motion carried:

AYES: Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

NAYS: None.

Dr. Jack Callan, Chairman of the Animal Control Advisory Committee, reported to the Council the Committee's findings of the recent trip to M. D. Anderson Research Facilities. On September 19, 1985, Committee Members Dr. Callan and Dr. Larry Ellis, along with Councilman Walter E. Wheat, Director of Community Services Mike Hall, and Mrs. Sam Madison, representing the Taylor-Jones Humane Society made an on-site inspection of the M. D. Anderson Facility. The purpose of the trip was to investigate the facilities and determine whether it was a good idea to continue sending dogs to the Research Facility.

Dr. Callan stated that the Facility was inspected by the U. S. Department of Agriculture, National Institute of Health and the American Association for Accreditation of Animal Laboratory Care. The Facility is inspected without notice by these governmental agencies to see that they are operating according to regulations and that any break in these regulations would jeopardize the entire research. They found the Facility clean and the dogs being treated humanly. He also stated that the dogs are only used when no other species of animal is acceptable. The Committee recommends the Council authorize the Animal Control Superintendent to continue sending animals to M. D. Anderson for research.

Councilwoman Ray moved to authorize the staff to continue the ongoing agreement with M. D. Anderson Research Facility. The motion was seconded by Councilman Robinson and the motion carried:

AYES: Councilman McCaleb, Councilwoman Ray, Councilmen Wheat, Fogle, Robinson, Nixon and Mayor Stubbeman.

NAYS: None.

Mayor Stubbeman recessed the Council into executive session in accordance with State law, Sections 2e and 2g of the Open Meetings Act, to consider pending and contemplated litigation and the appointment and evaluation of public officials.

The Council reconvened from executive session and reported no action taken.

There being no further business, the meeting was adjourned at 11:45 a.m.
