

McCaleb was present and presiding with Councilman Paul R. Vasquez, Councilwoman Betty Ray, Councilmen Jack Grable, Ray Ferguson, Bill Terry, and Councilwoman Liz Herrera. There being no corrections, additions, or deletions to the minutes of the Pre-Council Session and Regular City Council Meeting held May 14, 1992, Councilman Terry moved to approve the minutes as printed. The motion was seconded by Councilwoman Ray and the motion carried.

AYES: Councilman Vasquez, Councilwoman Ray, Councilmen Grable, Ferguson, Terry, Councilwoman Herrera, and Mayor McCaleb.

Mayor McCaleb presented a proclamation for May 31-June 6, 1992 as Say-So Week.

Councilman Grable moved to approve consent agenda items 6b and 6c, and 7a through 7f, and first reading of consent agenda item 6a; all as recommended by the staff. The motion was seconded by Councilman Vasquez and the motion carried.

b. Mindy Manson, Assistant Director of Planning and Development Services for Planning, briefed the Council on an Ordinance considered on second and final reading changing zoning district boundaries - Z-00692 - Request from Herman Schaffer; agent, Bill Senter, to rezone from RM-3 (Residential Multi Family) to O (Office) district, located in the 2900 block of S. 27th St. The Planning and Zoning Commission and staff recommend approval.

Mayor McCaleb opened a public hearing on the item, and the following individuals spoke in response to the request:

- . Scott Senter, Senter Realtors, property owner in the area, stated this type of business would have little impact compared to apartments being built.
- . Herman Schaffer, proponent.
- . Linda Smith, Sycamore Street, spoke on behalf of her mother, 2625 Woodland, stated business will be accessed through the alley, eliminating her mother's privacy, and increasing traffic and noise.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Vasquez moved to approve the Ordinance changing zoning district boundaries from Residential Multi Family to Office district, located in the 2900 block of S. 27th St., as recommended by staff. The motion was seconded by Councilman Grable and the motion carried.

Councilman Terry moved to approve the Ordinance changing zoning district boundaries from Light Industrial to Planned Development district, located on U. S. Highway 84 West (W. Hwy. 80), as recommended by staff. The motion was seconded by Councilwoman Herrera and the motion carried.

AYES: Councilman Vasquez, Councilwoman Ray, Councilmen Grable, Terry, Ferguson, Councilwoman Herrera, and Mayor McCaleb.

Nays: None.

The Ordinance is numbered 24-1992 and is captioned as follows:

AN ORDINANCE OF THE CITY OF ABILENE, TEXAS, AMENDING CHAPTER 23, SUBPART E, "ZONING", OF THE ABILENE MUNICIPAL CODE, CONCERNING PDD #51 PLANNED DEVELOPMENT DISTRICT; CALLING A PUBLIC HEARING; PROVIDING A PENALTY AND AN EFFECTIVE DATE.

d. Mindy Manson, Assistant Director of Planning and Development Services for Planning, briefed the Council on an appealed Ordinance considered on second and final reading changing zoning district boundaries - Z-01792 - Request from I. S. Gathright, agent David Hail, to rezone from AO (Agricultural Open Space) to RS-12 (Residential Single Family) district, located north of The Fairways Addition and east of Woodlake Addition. Staff recommends approval, the Planning and Zoning Commission recommends disapproval.

Mayor McCaleb stated that this is strictly a development issue and before the public hearing opened, he asked that those speaking respond to the following alternatives: 1) What is the wisest and best way to develop; and

2) With no provision for traffic to go eastward, the traffic flow and patterns are a major concern but there is a possibility of having the thoroughfare plan modified to allow traffic to go from mid point of the area east to the railroad tracks and add a collector street south. Mayor McCaleb then opened a public hearing on the item, and the following individuals spoke in response to the request:

- . David Hail, proponent, 23 Cherry Hills, stated he feels it is a positive move for Abilene and finds the only opposition is to the traffic, but supports the east entry recommendation.
- . Bruce Bixby, #4 Lytle Lake, in favor.
- . Don Onstott, #2 Cypress Point, feels this would be building without vision.
- . Gary Shahan, 2459 Old Orchard, stated the Gaithrights will dedicate land to create roads if property is permitted to be developed.
- . Diana Moore, 6 Hoylake, opposes traffic and negative impact.
- . Warren Moore, 6 Hoylake, objects to ill conceived plan that does not consider the neighborhood.
- . Scott Senter, owns two developments by Hoylake, suggested Council request Union Pacific to abandon its right of way east of the planned development to enhance traffic safety. Mr. Senter also stated the agreements with the landowners state if the railroad abandons the right of way the land will be returned to the landowners.

The Council took a break at 11:00 a.m. for 10 minutes, then resumed the public hearing.

- . Vic Valentine, 1234 S. 2nd, urged the Council to find solutions because the proposal would benefit the economy.
- . Margie Peck, realtor at 2545 S. Danville, asked Council not to stop subdivisions from being built.
- . Eddy Moore, 99 Glen Abbey, stated traffic is to be expected, there are very few lots in Abilene now.
- . Eddy Stash, 4420 Queen Anne's Lace, opposes until the plan can be developed that is satisfactory to existing homeowners.
- . Tommy Law, president of Dynasty Homes, supports the request, stating a critical shortage on lots today.
- . Rick Worley, Southland Homes, stated Abilene is growing and lots are needed; the availability of houses is critical to growth.
- . Janell Howla, is looking for a lot to build on, urged Council to approve the request.
- . Steve Dyer, Pebble Beach & Olympic, stated Mrs. Moore indicated over 200 homes would be built, but found only 40 lots were available after checking with Mr. Hail.

- . Don Slatton, homeowner in Fairways, 50 Riviera, concerned about traffic and noise.
- . I. S. Gaithright, 2102 Gaithright Dr., proponent, stated traffic is a result of houses being built.
- . Eddy Chase, 1714 Meadowbrook, stated traffic will always be a problem and not all problems can be solved at one time.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Ferguson moved to amend the thoroughfare plan to allow for an east/west collector from the 81 acres to Hwy. 83/84 to provide for an extension from Canyon Rock South to Antilley Road and for City staff to pursue petitioning Union Pacific to abandon its right of way east of the planned development to further enhance traffic safety. The motion was seconded by Councilman Grable and the motion carried.

AYES: Councilman Vasquez, Councilwoman Ray, Councilmen Grable, Terry, Ferguson, Councilwoman Herrera, and Mayor McCaleb.

Nays: None.

Councilman Vasquez moved to approve the Ordinance changing zoning district boundaries from Agricultural Open Space to Residential Single Family district, located north of The Fairways Addition and east of Woodlake Addition, as recommended by staff. The motion was seconded by Councilman Terry and the motion carried.

AYES: Councilman Vasquez, Councilwoman Ray, Councilmen Grable, Terry, Ferguson, Councilwoman Herrera, and Mayor McCaleb.

Nays: None.

The Ordinance is numbered 25-1992 and is captioned as follows:

AN ORDINANCE AMENDING CHAPTER 23, "PLANNING AND COMMUNITY DEVELOPMENT", SUBPART E, "ZONING", OF THE ABILENE MUNICIPAL CODE, BY CHANGING THE ZONING DISTRICT BOUNDARIES AFFECTING CERTAIN PROPERTIES, AS DESCRIBED BELOW; DECLARING A PENALTY, AND CALLING A PUBLIC HEARING.

e. Roy McDaniel, Assistant City Manager, briefed the Council on an Oral Resolution increasing the rate structure for Abilene Emergency Medical Services. Mr. McDaniel requested that the minutes reflect appreciation for this business.

Councilman Vasquez moved to approve by Oral Resolution to increase the rate structure for Abilene Emergency Medical Services, as recommended by staff. The motion was seconded by Councilwoman Herrera and the motion carried.

AYES: Councilman Vasquez, Councilwoman Ray, Councilmen Grable, Terry, Councilwoman Herrera, and Mayor McCaleb.

Nays: None.

ABSTAIN: Councilman Ferguson.

Roy McDaniel, Assistant City Manager, distributed to the Council a form from Condley & Co. showing Council approval of Councilman Ferguson voting on matters involving their clients. Mr. McDaniel explained the Council must give approval by voting on the matter, but that it is a requirement by the CPA firm, not the City. Councilman Grable moved to allow Councilman Ferguson to

vote on issues as addressed by Condley & Company. The motion was seconded by Councilwoman Herrera and the motion carried.

AYES: Councilwoman Ray, Councilmen Grable, Terry, Councilwoman Herrera, and Mayor McCaleb.

Nays: None.

ABSTAIN: Councilmen Vasquez and Ferguson.

f. Roy McDaniel, Assistant City Manager, briefed the Council on a Resolution authorizing issuance of Abilene Health Facilities Development Corporation hospital revenue bonds (Series 1992) for Hendrick Medical Center for hospital and health related projects in an amount not to exceed \$23,950,000. Staff and the Abilene Health Facilities Development Corporation recommend approval.

Councilman Terry moved to approve the Resolution authorizing issuance of Abilene Health Facilities Development Corporation hospital revenue bonds (Series 1992) for Hendrick Medical Center for hospital and health related projects in an amount not to exceed \$23,950,000, as recommended. The motion was seconded by Councilman Grable and the motion carried.

AYES: Councilwoman Ray, Councilmen Grable, Terry, Ferguson, Councilwoman Herrera, and Mayor McCaleb.

Nays: None.

ABSTAIN: Councilman Vasquez, due to his employment at Hendrick Medical Center.

The Resolution is numbered 27-1992 and is captioned as follows:

RESOLUTION OF THE CITY COUNCIL APPROVING THE SALE AND ISSUANCE OF BONDS BY THE ABILENE HEALTH FACILITIES DEVELOPMENT CORPORATION FOR THE PURPOSE OF FINANCING AND REFINANCING CERTAIN HEALTH FACILITIES FOR THE BENEFIT OF HENDRICK MEDICAL CENTER; CONFIRMATION OF PUBLIC HEARING REQUIREMENTS FOR PROJECT; APPROVING THE BONDS AND PROJECT AS REQUIRED BY SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED; PROVIDING AN EFFECTIVE DATE.


