- . Liana Booth, 125 Trail Way Drive, stated the business has proven irresponsible.
- . Jesse Hernandez, Pleasant Hill Mobile Home Park, Lot 11, complained about the noise.



- . Mary Medley, 109 Trail Way Drive, resident in the area, stated it was dangerous and will increase violence, noise, and possibly deaths.
- . Liana Booth, 125 Trail Way Drive, stated the business has proven irresponsible.
- . Jesse Hernandez, Pleasant Hill Mobile Home Park, Lot 11, complained about the noise.

There being no one else present and desiring to be heard, the public hearing was closed.
