The City Council of the City of Abilene, Texas, met for a Special Council Meeting on May 6, 1993 at 9:00 a.m. in the City Council Chambers of City Hall for the purpose of canvassing the results of the May 1, 1993 City Council election. Mayor Gary D. McCaleb was present and presiding with Councilman Paul R. Vasquez, Councilwoman Betty Ray, Councilmen Bill Terry, Ray Ferguson, and Councilwoman Liz Herrera. Also present were City Manager Jim C. Blagg, Assistant City Manager Roy L. McDaniel, City Attorney Harvey Cargill, City Secretary Jo Moore, and Assistant to the City Manager Debra Guerra.
