# CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, BASEMENT CONFERENCE ROOM, CITY HALL

The City Council of the City of Abilene, Texas, met in a Pre-Council Work Session on June 10, 1993, at 8:30 A.M. in the Basement Conference Room of City Hall. Mayor Pro Tempore Paul R. Vasquez was present and presiding with Councilwoman Betty Ray, Councilman Russell Berry, and Councilwoman Liz Herrera. Also present were City Manager Jim C. Blagg, Assistant City Manager Roy L. McDaniel, Assistant City Attorney Claudia Clinton, City Secretary Jo Moore, Assistant to the City Manager Debra Guerra, and various members of the City staff. Mayor Gary D. McCaleb and Councilmen Jimmy McNeil and Ray Ferguson were absent.

Mr. Doug Morton, Abilene citizen, suggested this project should only be done if it is legitimate, good, needed, and Abilene can pay for it.

Councilwoman Ray moved to approve the Resolution authorizing the City of Abilene to draw down loan funds under Section 108 of the Housing and Community Development Act of 1974 for the purpose of paying predevelopment costs associated with Windsor Housing Project as recommended by staff. Their input will then be incorporated in to the proposed plan. No action was required.

Mayor Pro Tempore Vasquez recessed the Council into executive session pursuant to Sections 2e and 2g of the Open Meetings Act, and to seek the advice of the City Attorney with respect to pending and contemplated litigation and to consider the appointment and evaluation of public officers.
