BUDGET WORK SESSION JULY 19 and 20, 1993

CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, BASEMENT CONFERENCE ROOM

July 19, 1993

The City Council of the City of Abilene, Texas, met in a budget work session on July 19 and 20, 1993, in the Basement Conference Room of City Hall. Mayor Gary D. McCaleb was present and presiding with Councilman Paul R. Vasquez, Councilwoman Betty Ray Councilmen Jimmy McNeil, Russell Berry, Ray Ferguson and Councilwoman Liz Herrera. Also present were City Manager Jim C. Blagg, Assistant City Manager Roy McDaniel, Director of Finance David M. Wright, City Secretary Jo Moore, and Assistant to the City Manager Debra Guerra.

The Council convened at 1:30 p.m. on July 19, 1993. Invocation was given by Councilman McNeil. City Manager Jim Blagg opened the session by stating an overall view of the general fund would be looked at. He gave an historical perspective from 1983 to present of various services provided and then stated in looking at employees vs. payroll from FY 84 to FY 93, payroll is up 11.6% and the number of employees is down 2.7%.

The proposed General Fund Budget is \$39.7 million, which is a 3.6% increase over the approved FY 93 Budget; with \$275,000 going to the equipment replacement fund. The main objective of the budget is the City's and Organization's ability to provide better service. The effective tax rate is a reduction from 61.25 cents to 60.00 cents.

The Environmental Protection Agency has mandated new requirements for this next fiscal year which will result in fee increases. Finance Director David Wright submitted information regarding state and federal mandates and overviewed the tax rate, values, and costs of federal mandates. Mayor McCaleb stated that we need to create an awareness for people to communicate back to Congress and the Legislators the increasing concerns about the mandates.

The General Fund was reviewed, including the revenue and expenditures summaries.

Economic expectations as reflected by income from the sales tax and franchises were reviewed.

Handouts were given to the Council regarding requests for funding. Mayor McCaleb questioned the rationale in the requests and the City Manager's in the proposed amounts budgeted. The City Manager explained the rationale from his perspective. Pam Collins, Director of Administrative Services, reported for the Council's information the numbers of holidays celebrated by State, School, and County entities as well as some local businesses. The Council discussed input they had received as well as their personal feelings concerning the Martin Luther King holiday.

Roy McDaniel, Assistant City Manager, overviewed the water and sewer funds, and equipment replacement fund.

The Council reviewed information distributed by Mike Morrison, Director of Economic Development regarding the Development Corporation of Abilene's proposed budget; and the Community Development summary of projects, which includes the following new programs: Senior Citizens program (portion), Community Action Program (office space), Family Outreach, and Rose Park (ADA improvements).

There being no further business, the meeting adjourned at 5:15 p.m.

July 20, 1993

The Council convened at 1:30 p.m. Mayor McCaleb asked Councilman McNeil to inform the rest of the Council of the death of Jenny Sanders; Councilman McNeil asked all to remember her family. Invocation was given by Councilman Ferguson.

The Council began their budget worksession by reviewing funds other than the General Fund, which was completed the previous day. Funds reviewed were:

- . Housing Fund
- . Senior Citizens
- . Health Services
- . Transportation Planning
- . Transit System
- . Transit System Cap Items proposed for FY '94
- . Cypress Plaza Office Building and Parking Facilities
- . Self Insurance Fund

David Wright, Finance Director, gave an update on the tax roll. As of this date (July 20, 1993), the effective rate can be lowered to 59.25 cents depending on property values. Mr. Wright also noted a correction to the budget: the Electric franchise should reflect \$60,000 more, bringing the total General Fund to \$60,000 more.

Mayor McCaleb commended the staff on the budget preparation, noting it is one of the <u>soundest</u> and <u>tightest</u> budgets which will allow us to reduce the tax rate; the blended perspective of the City Council produced this budget.

Mayor McCaleb stated he would like the following suggestions and observations to go on record:

- 1. Add \$54,000 for the Convention and Visitors Bureau.
- 2. Reduce the Equipment Replacement Fund by \$75,000. If there is a positive balance at the end of the year, the \$75,000 can go back to the fund.
- 3. Reduce by \$26,000 the Seal Coating program (Street Maintenance).
- 4. The key to the success for the City lies with it's employees' quality and dedication to doing a good job. In the coming year do a <u>very thorough</u> study of employee pay, sick leave, longevity, etc. to do everything possible to state appreciation to employees and provide compensation.

The tax rate will be 58.75 cents with the noted adjustments.

Councilman Vasquez voiced his appreciation to the Mayor, Council and staff, indicating this was his third budget session.

Councilman Ferguson urged communication between citizens and government, noting Councilman Berry's suggestion to televise Council meetings.

Mr. Blagg stated Mr. McDaniel is looking at ACU and the School District for televising the meetings; stating that funding is available in the City Council budget.

Councilman Vasquez suggested a committee of Councilmembers could work with staff on communication with citizens.

Councilman Vasquez moved to approve first reading of the Ordinance approving the revised 1992-93 budget as amended, the proposed budget for FY 1993-94 as amended; and call a public hearing for August 26, 1993 at 9:00 a.m. The motion was seconded by Councilwoman Herrera and the motion carried.
