The City Council of the City of Abilene, Texas, met in a Pre-Council Work Session on August 26, 1993, at 8:30 A.M. in the Basement Conference Room of City Hall. Mayor Gary D. McCaleb was present and presiding with Councilman Paul R. Vasquez, Councilwoman Betty Ray, Councilmen Jimmy McNeil, Russell Berry, Ray Ferguson, and Councilwoman Liz Herrera. Also present were City Manager Jim C. Blagg, Assistant City Manager Roy L. McDaniel, City Attorney Harvey Cargill, Jr., City Secretary Jo Moore, Assistant to the City Manager Debra Guerra, and various members of the City staff.

Assistant City Manager Roy McDaniel noted a correction on page 5b-1, stating the memo should read, "..funding of 5 Dispatchers/Call Takers in the Communications Center and 1/2 position in the Fire Department." Mr. McDaniel also noted on the 9-1-1 budget under the Contingency line item for FYTD 7/31/93 the amount should be -0-, not \$5,000. There being no corrections, additions, or deletions to the minutes of the Pre-Council Session and Regular City Council Meeting held August 12, 1993, Councilman McNeil moved to approve the minutes as printed. The motion was seconded by Councilman Vasquez and the motion carried.

AYES: Councilman Vasquez, Councilwoman Ray, Councilmen McNeil, Ferguson, Berry, Councilwoman Herrera, and Mayor McCaleb.

NAYS: None.

Councilman Vasquez moved to approve consent agenda items 5a, 5b, and 6a through 6c; and approval of first reading of agenda item 5c, as recommended by the staff. The motion was seconded by Councilwoman Ray and the motion carried.

David Wright, Director of Finance, briefed the Council on an Ordinance considered on second and final reading approving the Proposed FY 1992-93 Tax Levy.

Mayor McCaleb stated that items 7a and 7b would be considered together, but that a separate motion and vote on each item would be taken.

Mayor McCaleb opened a public hearing, and the following individuals spoke on the items:

Diane Mehaffey, Executive Director of Noah Project, requested additional funding to expand transitional housing.

- . Connie Mangin, President, Board of Directors for Family Outreach.
- . Ken Deckerd, Community Action Program, 634 E. N. 19th, requested the MLK holiday be implemented.
- . Debra Bell, 1781 Lakeshore, spoke on the MLK holiday. Six holidays is maximum for small businesses; it's inappropriate for City due to expense.
- . Shirley Glandon, volunteer for Crime Victims Crisis Center, asked Council to reconsider and add \$10,000 to their funding.
- . Pat Frosh, Executive Director of Mend-A-Child, requested funds from the CDBG budget.
- . Wayne Roy, 4602 Carrie Ann, spoke as a citizen and noted the positive work of ACT Now, asked Council to do nothing to hurt what has been established.
- . Gayle Kiser, coordinator of Abilene Non Profit Management; money helps underwrite services.
- Rev. Leo Scott, 1309 Canterbury Dr., commended the Council on the MLK holiday, whatever decision is made will be understood.
- . Billy Bowles, 1109 Green St., consider city employee pay raise, feels they are underpaid; especially police and fire.
- . Lynda Calcote, 3499 Santa Monica, in favor of MLK holiday.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Vasquez stated the City staff has done really well in working with the Council in a proper shifting of expenses and feels the budget supports a broad representation and base.

Councilwoman Ray stated her appreciation of staff and community and feels the City services have been properly balanced.

Councilwoman Herrera stated she had received a variety of calls on the MLK holiday and is having a hard time doing for one and excluding others.

Councilman Ferguson stated he doesn't want to single out a particular group of people, but is for the MLK. He directed the Human Relations Committee to try to bring the entire community together. He cited a letter from the chair of that group, citing its desire to promote better relations among all. This broad principle has permitted Councilman Ferguson to support the holiday.

Mayor McCaleb thanked all in attendance, and stated he questioned some of the remarks made concerning the increasing cost of government over the past ten years. The Mayor requested additional information regarding number of employees hired during the past 10 years. City Manager Jim Blagg answered that there are 3% fewer employees than in 1983, with an 11.6% increase in payroll, and a 27.3% expenditures increase.

Councilman Ferguson noted the property tax is \$74,530 less than last year's.

Mayor McCaleb stated it is important to note that there is a shifting of the property tax burden to sales tax. To all representing various agencies, he stated that this Council deeply appreciates the work each has done in touching the lives of people. Funds are limited, but the Council tries to provide what is possible, symbolic to the work of each agency. Regarding City employees, he stated his appreciation of City employees continues to rise. The Mayor noted the pay raises may reflect limitations, but the percentage in the budget hopefully at least indicates attempts to go forward.

Councilman Ferguson moved to approve the Ordinance considered on second and final reading approving the Revised FY 1992-93 and Proposed FY 1993-94 Budgets with 8 set holidays which would include one floating holiday, the Martin Luther King Day, and six holidays to be set by the City Manager; and Resolution approving Final Statement of Objectives and Projected Use of Funds for Community Development Block Grant funds; all as recommended by staff. The motion was seconded by Councilman Berry. Mayor McCaleb stated, "Because of the way the motion has been made makes it difficult to vote for the budget without voting for the condition which Mr. Ferguson attached to it. I certainly am not inclined to vote against the budget because I think it's a very good budget, personally I do not feel that it would have been problematic to have added the MLK holiday as an additional holiday. Being sensitive to all the cost implications in the study of holidays, there are many factors that have to be looked at and considered in this. I know we have a range of holidays that different businesses and organizations take and I think we would have found that whether we would have added an extra day or stayed with this date, either way, we are still very comfortably in the middle range of holidays being taken when looked at on the broader scale. But, with that note I do think we have a very solid budget and would not want to be put in a position were I was caused to vote against the budget, and therefore would vote yes." The motion carried.
