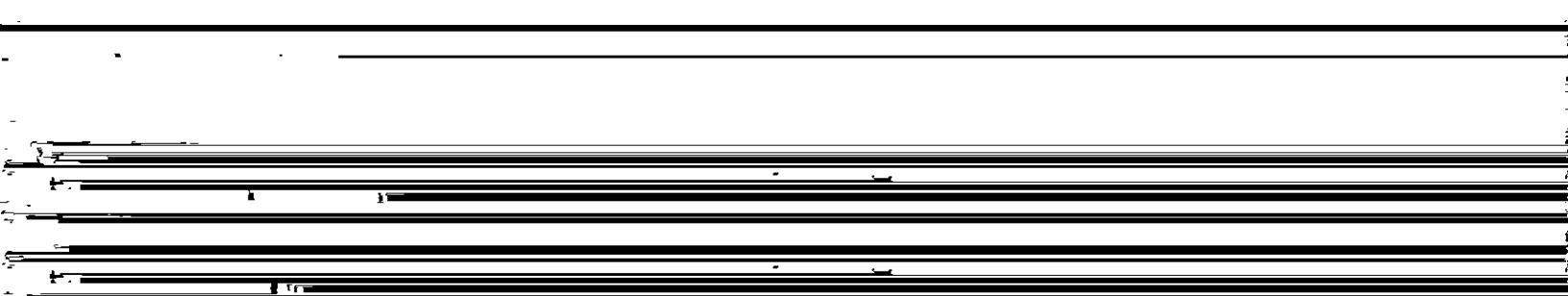

The Council reconvened from executive session and reported no action taken.





7. Award of Bid:

- a. Removed from Consent Agenda to be considered separately.

Mike Hall, Director of Community Services, briefed the Council regarding the Rose Park Swimming Pool modifications, Bid #CB4017. Staff recommends Council accept the architect's recommendation to award the bid to Bill Starks Construction, the low bidder in the amount of \$122,400.00.

Dennis Watson, Southwest Pools, asked the Council to reject the award of bid to Starks Construction and award it to the next lowest bidder, or reject all bids and start over. He addressed the Council with four of the specifications he believes were not met:

1. List similar project completed in the last three years;
2. Debts - proof of no debts to the City at least three working days prior to the bid opening;
3. Starks has two Federal tax liens against him; Tax suit against him by Central Appraisal District; and
4. Architect may design - doesn't mean anyone can construct one.

Newt Newberry, Architect on the project, reviewed the evaluation process; indicating the bid by Starks Construction would be a \$20,000 savings to the City.

Jim Blagg, City Manager, responded to the points raised by Mr. Watson as follows: Specification 12.2 - The procedure the City considers to determine if the bidder is qualified to do the work; the procedure has been verified by a Court Judge. Mr. Starks contends the debts mentioned were from a previous company, not the current one, but still the taxes have been paid. The Legal and Building department interpretations of exemption #2 - is that a licensed pool contractor is not required if designed by an architect. Mr. Blagg stated the performance bond will be required. Starks Construction was the lowest responsible bidder by \$20,000.

Harvey Cargill, City Attorney, stated there is no known reason why the bid should not be awarded as recommended.

Councilman Vasquez moved to accept the architect's recommendation to award the bid to Starks Construction, the low responsible bidder in the amount of \$122,400 as recommended by staff. The motion was seconded by Councilman Berry and the motion carried.

Dr. Norman Archibald, Oversight Committee chair, gave a slide presentation on the United Way FOCUS Needs Assessment program, then introduced Rene Moquin, Project Manager, who focused on five areas/issues of major concern:

1. Lack of Affordable Medical Care
2. Unemployment in Neighborhoods
3. Neighborhood Crime
4. Shortage of Recreational Facilities
5. Legal Needs

Some overall pervasive themes are Juvenile crime, lack of programs for older youth, areas of low income same as 1980, economic challenge to develop training for the workforce, number of residents living in low income growing faster than the population as a whole, crime is down, but sex offenses and disorderly conduct are up, large percent of households impacted by lack of medical care, doctors not accepting Medicaid, assessing services remains a major barrier.


Mayor McCaleb stated it is very important to have ways to listen to the City and County citizens, indicating our task is to respond. The Mayor again recognized the Needs Assessment Partners in attendance and stated appreciation for the number of ways we're seeing progress having been, and is being, made.

No motion was required.


