7. Award of Bid:

The bid was awarded by oral resolution to Eagle Contracting Corporation of Kellar, the low responsible bidder in the amount of \$3,886,000.00 and the City Manager was authorized to execute a contract on behalf of the City, as recommended by staff.
- b.Water treatment chemicals for Water Department, **Bid CB4036**. The bid was awarded as follows: Anhydrous ammonia to DPC Industries, Inc. for the unit price of \$540.00; Liquid aluminum sulfate to Russ Chemical Co. for the unit price of \$135.42; Sodium hydroxide to Coastal Products for the unit price of \$120.00; Pebble quicklime to Texas Lime Co. for the unit price of \$61.05; and Sodium hexametaphosphate to Harcros Chemicals for the unit price of \$1,188.00 and that the Chlorine Gas and Liquid Cationic Polymer bids be rejected and rebid at a later date; all as recommended by staff.
- c.Renovation of the Abilene Regional Business and Education Center Phase I Small Business Development Center, **Bid CB4030**. The bid was awarded to Sunwest Construction, Inc. of Lubbock, the low responsible bidder in the amount of \$102,350.00, as recommended by staff.

8. Special Considerations:

a. Jo Moore, City Secretary, briefed the Council on a Resolution canvassing the results of the May 7, 1994 General Election, declaring that Paul Vasquez and A. Don Drennan received a majority of the votes cast for Councilmembers Place I and IV respectively. Total votes cast were as follows: Council Place 1: Paul Vasquez - 3678; Jerry Paul Shadid - 815. Council Place II: Karl Karrenbrock - 1692; W. E. "Buff" Hackney - 280; A. Don Drennan - 2649.

Mayor McCaleb received by mail a Ballot and Seal Certificate from each presiding judge, duly signed by same and released to the City Secretary for filing in the official election records.

Councilman Ferguson moved to approve the Resolution canvassing the returns and declaring the results of the City Council election held May 7, 1994. The motion was seconded by Councilman McNeil and the motion carried.

9. Other Business:

- a. Melvin Martin, Chief of Police, briefed the Council on the President's Crime Bill and how we will be affected locally. Chief Martin stated it was difficult getting good information on what's required and that the rigidity, inflexibility, and excessive amount of documentation show the program to have been written to eliminate cities. No action was required.
- b. Harvey Cargill, City Attorney, briefed the Council on a **Public Hearing** to consider a Resolution approving suspending the proposed Lone Star Gas Rate Increase for Ninety (90) days; and to consider on first reading an Ordinance setting rates, authorizing City Manager to hire rate analyst if necessary. Staff recommends approval.

Mayor McCaleb opened a public hearing on the item, and the following individual spoke in favor of the request:

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Ferguson moved to approve the Resolution suspending the proposed Lone Star Gas Rate Increase for Ninety (90) days; and to approve first reading of an Ordinance setting rates, authorizing City Manager to hire rate analyst if necessary, as recommended by staff. The motion was seconded by Councilman Vasquez and the motion carried.
