There being no corrections, additions, or deletions to the minutes of the Pre-Council Session and Regular City Council Meeting held June 9, 1994, Councilman Vasquez moved to approve the minutes as printed. The motion was seconded by Councilman Berry and the motion carried.

Wayne Herrington, Principal Planner, briefed the Council on an Ordinance considered on second and final reading changing zoning district boundaries - **Z-02494** - Request from Carroll Cockerell; agent Dr. John Glenn, to rezone from AO & O (Agricultural Open Space & Office) to PDD (Planned Development) district, located at 2249 E. N. 10th St. The Planning and Zoning Commission and staff recommend approval.

b. Wayne Herrington, Principal Planner, briefed the Council on an Ordinance considered on second and final reading changing zoning district boundaries - **Z-03194** - Request from SCI Texas Funeral Services, Inc.; agent Wes Killian, to rezone from AO (Agricultural Open Space) to GC (General Commercial) district, located on Hwy. 277 South. The Planning and Zoning Commission and staff recommend approval.

Mayor McCaleb opened a public hearing on the item, and there being no one present and desiring to be heard, the public hearing was closed.

Councilwoman Herrera moved to approve the Ordinance to rezone from Agricultural Open Space to General Commercial district located on Hwy. 277 South, as recommended by staff. The motion was seconded by Councilman Drennan and the motion carried.

c. Ron Quarles, Acting Assistant Director of Development Services for Planning, briefed the Council on a Resolution approving the Buffalo Gap Road Corridor Land Use Study. An addendum was distributed at the Pre-Council session recommending the study incorporate Mesa Springs Retirement Village, PDD #37. The Planning and Zoning Commission and staff recommend approval.

Mayor McCaleb opened a public hearing on the item, and the following individual spoke in

.Mike Richards, a resident of Buffalo Gap Road since 1954, questioned what the citizens committee that he has been asked to serve on will do.

Mayor McCaleb stated today's decision doesn't change the current zoning, the committee will bring recommendations for an overlay district. City Manager Jim Blagg explained that this <u>is</u> not a zoning issue, but is a guideline or plan for future public and private development in the area.

Councilman Drennan commended the staff and citizens involved.
