The City Council of the City of Abilene, Texas, met in a Pre-Council Work Session on April 27, 1995, at 9:30 A.M. in the Basement Conference Room of City Hall. Mayor Gary D. Vasquez and Ray Ferguson were absent.

4.1 **Public Appearance**

Debra Guerra, Assistant to the City Manager, introduced Dr. Nancy Jones, Co-Chair of the Abilene's Children Today (ACT-1) task force, who presented their final report and requested Council to formally accept the report. Mayor McCaleb expressed his appreciation to Dr. Jones and Frank Puckett for their leadership and Debra Guerra for staff support. He stated that from the beginning this has not been presented as a government project; it has created higher awareness of what we're doing or need to do. Now we need to follow up with group and citizens involvement. Dr. Jones recommended coming back in April of 1996 to see what's been accomplished.

Councilman Drennan moved to accept the ACT-1 report as presented and integrate it into the Strategic Plan; and emphasized his appreciation for the awareness, child involvement, and cross section of citizens. He thanked the Mayor for his insight and leadership, along with Ms. Guerra, Dr. Jones, and Mr. Puckett for their work. The motion was seconded by Councilman Berry and the motion carried.

Mr. Smith opened and read all bids aloud.

Following staff verification of the arithmetic on the bids, Councilman McNeil moved to approve the bid from Legg Mason Wood Walker, Inc.; Paine Webber, Inc.; Rauscher Pierce Refsnes, Inc.; and Smith Barney, Inc. at the net interest cost of \$899,412.50 and the effective interest rate of 5.467553%, and to approve the Ordinance authorizing issuance of City of Abilene, Texas, Combination Tax and Revenue Certificates of Obligation, Series 1995 in the amount of \$2,100,000 as recommended by staff. The motion was seconded by Councilman Berry and the motion carried.
