CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, BASEMENT CONFERENCE ROOM, CITY HALL

The City Council of the City of Abilene, Texas, met in a Pre-Council Work Session on August 10, 1995, at 8:30 A.M. in the Basement Conference Room of City Hall. Mayor Gary D. McCaleb was present and presiding with Councilmen Paul R. Vasquez, Jimmy McNeil, Russell Berry, Ray Ferguson, and Councilwoman Kay Alexander. Also present were City Manager Lanny Lambert, City Attorney Harvey Cargill, Jr., City Secretary Jo Moore, Assistant to the City Manager Debra Guerra, and various members of the City staff. Councilman A. Don Drennan was absent.

The Council briefly discussed various consent and regular agenda items, and there being no further discussion, the meeting was recessed to the City Council Chambers until 9:00 a.m. for the regular Council Meeting.

REGULAR AGENDA

Resolutions

4.1 Mike Morrison, Director of Economic Development, briefed the Council regarding a Resolution to amend the FY 1994/95 Community Development Block Grant (CDBG) Final Statement to include the proposed Downtown Revolving Loan Program and receive citizen comments on the FY 1993/94 Grantee Performance Report.

Staff recommended Council hold the public hearing for this item and items 4.2, Ordinance approving revised 1994-95 and proposed 1995-96 budgets; and 4.3, Ordinance setting FY 1995-96 tax levy. At the conclusion of the public hearing, separate votes will be taken for each item.

Mayor McCaleb opened a public hearing on the items, and the following individuals spoke in response to the items:

- Roger Berry, President of the Abilene Police Officers Association, asked Council to listen with open minds and hearts, and addressed what he believed to be misconception in 1994 across the board (misleading); this year was across the board. Abilene Police Officers' salaries are below the median. He addressed comparisons he felt were inaccurate, and asked Council to consider Chief Martin's recommendation for a 6.8% pay raise.
- .Guy Turner, President of the Abilene Firefighters Association, feels the 6% recommended pay raise by the City Manager was fair.

.Betty Reynolds, 1925 Beltway South, feels a small tax increase to give a raise is worth it.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Vasquez stated that the statement that the Council has ignored the statistics and involvement in the community by the Police and Fire Departments are not true - all employees need to be considered, it's hard to separate employees and make them different. He stated dangers were mentioned, and said every job has some danger; we must question what comes with every job. Councilman Vasquez stated his appreciation and support for the Fire and Police Departments. Councilman Ferguson agreed.

Mayor McCaleb stated his appreciation to Mr. Turner and Mr. Berry for speaking on behalf of the employees who serve the community. There is no question that all seven council members have the very highest regard for the Police and Fire Departments. He expressed his disappointment at the column recently published, stating it was said they didn't deserve a raise. Mayor McCaleb stated he finds the statement quoted is very hard to believe, that not even a suggestion of such a statement was made. Open communication is vital through dialogue, surveys, and information. The Council has not chosen to ignore surveys. A percent of surveys can be misleading if used in certain ways; it is unfortunate if anyone feels the Council is willing to settle for our community to be below average; he believes we are far above average, and the quality of people is how we sense that worth. It is difficult to pay employees what they deserve or what they are worth. Pay is not the only indicator of the value of employees, in every area, they are always worth more. The reality of the fact is that there are hundreds who deserve to be paid more. Typical pay increases over the past three years has been 3% in the areas of employment. Nothing across the state or other cities indicate more than 3%. He stated his deep appreciation for the work of the departments and will continue to look for ways to support them.

Councilman McNeil moved to approve the Resolution to amend the FY 1994/95 Community Development Block Grant (CDBG) Final Statement to include the proposed Downtown Revolving Loan Program and the FY 1993/94 Grantee Performance Report, as recommended by staff. The motion was seconded by Councilman Berry and the motion carried.
