4.1 Jim Nicholas of 4610 Hummingbird Circle, representing Dick Dansby, presented a petition regarding a zoning request for intersection of Catclaw and Rebecca Lane. He stated that residential zoning is requested, and noted that it appears the northeast corner of the intersection has been zoned RM-2 (Residential Multi-Family) since 1978. City officials are researching the correct zoning of the area. Thomas Choate, attorney for the property owners, Mr. & Mrs. O. B.
