CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, BASEMENT CONFERENCE ROOM, CITY HALL

The City Council of the City of Abilene, Texas, met in a Pre-Council Work Session on October 10, 1996, at 8:30 a.m. in the Basement Conference Room of City Hall. Mayor Gary D. McCaleb was present and presiding with Councilmen Paul R. Vasquez and A. Don Drennan, Councilwoman Carol Martinez, Councilmen Rob Beckham and Ray Ferguson (arriving at 8:50 a.m), and Councilwoman Kay Alexander. Also present were City Manager Lanny Lambert, Assistant City Manager Roy L. McDaniel, Assistant City Attorney Sharon Hicks, City Secretary Jo Moore, Assistant to the City Manager Debra Guerra, and various members of the City staff.

Sgt. DeFoor, Abilene Police Department, presented to the Council a framed poster representing the first 30 Police trading cards, which kicks off a new youth public awareness program. Sheldon Greene, Chair of the TIF Board Parking Committee, distributed statistical and additional information on item 4.1, "Committee report" to be presented during the regular Council meeting. A memo noting a typographical correction to item 3.2, increasing the total proposed bid figure by \$100.00 for the two fire apparatus, was distributed to Council. Council briefly discussed various other consent and regular agenda items, and there being no further discussion, the meeting was recessed to the City Council Chambers until 9:00 a.m. for the regular Council Meeting.

3.3 Marva Pritchett, Director of Public Works, briefed the Council on Award of Bid for two trolley buses, **Bid** #**CB6036**, which was removed from the Consent Agenda to be considered separately at the request of a citizen, who questioned the cost. Mrs. Pritchett outlined the funding as follows: \$397,600 from Federal Transit Administration funds, \$58,500 from State Public Transportation funds; \$29,400 from Tax Increment Finance District funds, and \$11,500 from Downtown Association contributions for a total of \$497,000. Staff recommends the bid be awarded to AAI/ACL Technologies Inc. for a total amount not to exceed \$497,000.

Councilwoman Martinez moved to award the bid to AAI/ACL Technologies Inc. for a total amount not to exceed \$497,000, as recommended by staff. The motion was seconded by Councilman Vasquez and the motion carried.

Public Appearance

4.1 Elizabeth Miller, Downtown Manager, briefed the Council on the TIF Board Parking Committee's report. Ms. Miller introduced Sheldon Greene, Chair of TIF Board Parking Committee, who presented the committee's report and recommendations.

Councilwoman Alexander stated appreciation for the positive solutions offered, and recommended that consideration be given to business owners allowing them free, or at least very inexpensive parking.

Mayor McCaleb asked staff to review the report and prepare specific solutions to the problems addressed.

No action was required.

Ordinances

4.2 Carl Lockett, Assistant Director of Public Works for Planning, briefed the Council on an Ordinance amending Sections 23-306.4, Permitted Uses (Accessory and Incidental Uses) and 23-306.5.B, Accessory and Incidental Uses, of the Zoning Ordinance to allow mobile homes as temporary accessory housing in AO zoning districts. The Planning and Zoning Commission and staff recommend approval.

Mayor McCaleb opened a public hearing on the item, and the following individuals spoke in response to the request:

.Steve Hood commended the prompt action from all involved, and stated his appreciation for the consideration given to such a sensitive issue.

.Bill Hilton, 682 EN 18th, requested clarification - stating a no vote should be made to the request for zone change, then the item should go to the Board of Adjustment.

Staff clarified for Mr. Hilton that this item is not the zone change request, but the Ordinance amendment that would allow the use of mobile homes as temporary accessory housing in AO zoning districts. If this amendment is approved, then the Board of Adjustment would consider any zone change request.

Councilman Drennan questioned the Ordinance being clear on complying with local codes. It was noted in subsection (c) it states all appropriate permits would have to be obtained, and the Building Official would inspect and verify all conditions as set forth are met before the mobile home could be occupied.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Drennan moved to approve the Ordinance amending Sections 23-306.4, Permitted Uses (Accessory and Incidental Uses) and 23-306.5.B, Accessory and Incidental Uses, of the Zoning Ordinance to allow mobile homes as temporary accessory housing in AO zoning districts, as recommended by staff. The motion was seconded by Councilman Vasquez and the motion carried.

Carl Lockett, Assistant Director of Public Works for Planning, briefed the Council on an Ordinance to rezone from AO to MH district located at 1601 Griffith Road. The Planning and Zoning Commission and staff recommend denial, and that the proponent pursue the request through the Board of Adjustment.

Mayor McCaleb opened a public hearing on the item, and there being no one present and desiring to be heard, the public hearing was closed.

Councilman Ferguson moved to deny the request to rezone from AO to MH district located at 1601 Griffith Road, and that the proponent pursue the request through the Board of Adjustment, as recommended by staff. The motion was seconded by Councilwoman Alexander and the motion carried.

Other Business:

Councilman Drennan left the meeting after the executive session.
