REGULAR AGENDA

4.1 Elizabeth Grindstaff, Interim Director of Planning & Development Services briefed the Council on **Z-0604**, an Ordinance considered on second and final reading to rezone property located at State Highway 36 and FM 18 from AO (Agriculture Open Space) and PDD-2 (Planned Development District) to PDD (Planned Development District) zoning district.

Ms. Grindstaff stated the rezone request, by the City of Abilene agent Richard Burdine, is to allow Tige Boats to construct a new boat manufacturing facility on the subject property. The PDD would allow the use and other similar uses, while also providing for aesthetic control including limitations on outdoor storage, landscaping, and signage. Although the area of the PDD is 94+ acres Tige Boats will be developing approximately 48 acres and the remainder of the property will be available for future development. It was noted the Council had received a revised version of the ordinance that clarifies language on the last page of Exhibit "A", Airport and Height related Provisions. The language that was added is to ensure that nothing will affect the use of the Airport as a result of development of this property. Staff and the Planning and Zoning Commission recommend approval of the rezone request.

• Richard Burdine, CEO of the Development Corporation of Abilene and the Assistant City Manager of Economic Development for the City of Abilene noted that Tige Boats is a major employer and recommended Council approve the rezone request.

4.2 Shannon Meinhold, Planner II, Planning & Development Services briefed the Council on **Z-1404**, an Ordinance considered on second and final reading to rezone property located at 2417-2425 Church Street from RS-8 (Residential Single-family) to RM-2 (Residential Multi-family) zoning district.

Ms. Meinhold stated the applicant Mr. Glen Basenger wishes to rezone the two vacant lots for the development of duplexes. The agent, Andy Stanton, would purchase the lots contingent upon the approval of the rezoning. The agent would construct a duplex on one lot, live in one side of it and rent out the other side. The other lot would be improved with a duplex at a later time. Staff and the Planning and Zoning Commission recommend approval of the rezone request.

• Andy Stanton, agent, requested Council approve the rezone request.
