CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas, met in Regular Session on July 22, 2004, at 8:30 a.m. in Council Chambers, 555 Walnut Street. Mayor Pro Tempore Anthony Williams was present and presiding with Councilmen Sam Chase, John Hill, Stormy Higgins, Kris Southward, and Councilwoman Laura Moore. Also present were City Manager Larry Gilley, City Attorney Sharon Hicks, City Secretary Jo Moore, and various members of the City staff. Mayor Archibald was absent.

Councilwoman Moore gave the invocation.

Baylee Landowski a second grade student from Austin Elementary School led the Pledge of Allegiance. Baylee's parents, grandmother Sandy Neith and grandfather Leonard Neith, who is employed by the City of Abilene's Solid Waste Department, were also present.

PRESENTATIONS

Councilman Southward presented a plaque to the City of Abilene and the CDBG fund on behalf of "Meals on Wheels" for allocation of funding for the new MOW building.

- 3.5 **Bid** #CB-4056 Airport Terminal Phase III Project. The base bid and Alternatives 1 and 3 was awarded to Jeff Luther Construction Co., Abilene, TX in the amount of \$1,063,000.
- 3.6 **Bid** #**CB-4065** New Health Facility at 850 N. 6th Street. The bid was awarded to Waldrop Construction Co., Inc., Abilene, TX in the amount of \$2,741,300.

REGULAR AGENDA

4.1 Elizabeth Grindstaff, Interim Director of Planning & Development Services briefed the Council on **Z-1904**, an Ordinance considered on second and final reading to rezone property located at the northern corner of I-20 and Hwy 351 from AO (Agriculture Open Space) and HC (Heavy Commercial) District to PDD (Planned Development District) zoning district.

Ms. Grindstaff stated the rezoning request involves property in the northern quadrant of the intersection of Interstate 20 and Highway 351 that includes 6 parcels and 4 owners, each desiring a rezoning designation of Planned Development District (PDD) to support the construction of a Wal-Mart Supercenter and several outbuildings. Originally the request included an additional 7.1

acre parcel owned by Mr. Kenneth Musgrave. Although Mr. Musgrave has withdrawn his property for rezoning consideration at this time Wal-Mart has committed to later include the 7.1 acre parcel in the proposed PDD once the ownership of the land has transferred from Musgrave Enterprises. Staff and the Planning and Zoning Commission recommend approval of the rezoning request.

Mayor Pro Tempore Williams opened a public hearing on the item and the following individuals addressed the Council:

- Tom Galbreath agent, Dunaway Associates. Mr. Galbreath's comments included: 1) reiterating Wal-Mart's plans to include Mr. Musgrave's property as soon as it is purchased; 2) the uniqueness of this proposed Wal-Mart; 3) Wal-Mart working with TxDot on future actions that will be taken concerning any traffic issues; 4) the background on engineering of the property; 5) dedication of right of way, and; 6) landscaping/wall screening.
- Barney Chapman Dairy Queen property owner. Mr. Chapman stated his endorsement of the rezoning and of a larger marketing sign for Wal-Mart.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilwoman Moore made a motion to approve **Z-1904**, an Ordinance considered on second and final reading to rezone property located at the northern corner of I-20 and Hwy 351 from AO (Agriculture Open Space) and HC (Heavy Commercial) District to PDD (Planned Development District) zoning district as recommended by staff and the Planning and Zoning Commission. Councilman Hill seconded the motion, and the motion carried.

Elizabeth Grindstaff, Interim Director of Planning & Development Services briefed the Council on **Z-2004**, an Ordinance considered on second and final reading to rezone property located in the 6600 block of Buffalo Gap Rd. from RM-2 (Residential Multi-family) District to SC (Shopping Center) zoning district.

Ms. Grindstaff stated the rezoning request involves a single parcel of land (approximately 7.7 acres) that is desired to support the future development of low-intensity and medium-intensity commercial uses. Staff and the Planning and Zoning Commission recommend approval of the rezoning request.

Council and staff's discussion included: 1) establishments that are currently allowed; 2) buffer, landscaping and screening requirements, and; 3) what visually would be seen by residents in the area with the future development.

Mayor Pro Tempore Williams opened a public hearing on the item and the following individual addressed the Council:

• Scott Senter – agent. Mr. Senter's comments included: 1) addressing the power line easements; 2) potential uses of the property; 3) screening and landscaping of the property; 4) speed limits in the area, and; 5) driveways onto Buffalo Gap Rd being regulated by TxDot and only one being allowed in this area.

There being no one else present and desiring to be heard, the public hearing was closed.

Councilman Hill made a motion to approve **Z-2004**, an Ordinance considered on second and final reading to rezone property located in the 6600 block of Buffalo Gap Rd. from RM-2 (Residential Multi-family) District to SC (Shopping Center) zoning district. Councilman Chase seconded the motion, and the motion carried.

The Ordinance is numbered **21-2004** and captioned as follows:

AN ORDINANCE OF THE CITY OF ABILENE, TEXAS, AMENDING CHAPTER 23, SUBPART E, "ZONING", OF THE ABILENE MUNICIPAL CODE, BY CHANGING THE ZONING DISTRICT BOUNDARIES AFFECTING CERTAIN PROPERTIES; CALLING A PUBLIC HEARING; PROVIDING A PENALTY AND AN EFFECTIVE DATE.
