3.3 Oral Resolution authorizing the City Manager to execute a contract with West Texas Golf Cars for interim shuttle service for the Terminal Phase IV Project.

Don Green Director of Aviation briefed the council on the Golf Cars for interim shuttle service for the Terminal Phase IV Project. The Airport has contracted with West Texas Golf Cars for the amount of \$6,125.00 per week to provide golf car shuttle service between the terminal and parking lot. This service is needed due to closing the terminal's lower level for the next phase of the terminal construction. This service will be required until the parking lot construction project reaches the stage where the planned shuttle service between the terminal and a temporary remote parking lot is implemented. The cost for this contract is \$6,125.00 per week and is eligible for 95% reimbursement through the FAA grant terminal project.

Council and staff discussion included: 1) had trouble finding vendors that could meet the city's contract requirements; 2) looked at using city employees; 3) looked at using CityLink: 4) covers 20 hours a day; 5) some factors in the cost include fuel and insurance costs; and 6) cost are reimbursable up to 95% with the Grant.

Item 3.5 considered separately at the request of Councilwoman Davis.

3.5 Oral Resolution authorizing the City Manager to execute a contract with a shuttle service provider for the parking lot project.

Don Green Director of Aviation briefed the council on the shuttle service. The City has twice solicited proposals from interested companies to provide a shuttle service between the terminal and a remote parking lot during construction of the new parking lot. One proposal was received from the first RFP and was rejected because Staff determined the cost exceeded the planned budget for this service. A second RFP has been solicited and proposals were received on December 4. The amount of \$300,000 has been budgeted in the project's overall cost.

Council and staff discussion included: 1) Request for Proposal earlier in the year was rejected; 2) shuttle buses are ADA compliant; 3) turnkey job; 4) one bus will run with one in reserve in case of problems; 5) no charge to the customer for bus fare; and 6) CityLink was looked at to provide the service, but they are having staffing shortages.

Councilman Spano made a motion to approve Item 3.3 Terminal Phase IV Interim Shuttle Service and Item 3.5 Parking lot construction shuttle service. Councilwoman Moore seconded the motion, and the motion carried.

REGULAR AGENDA

4.1 David Wright, Director of Finance briefed the council on the Ordinance amending Chapter 30, "Taxation" Relating to Tangible Personal Property in Transit.

During the 80th Legislative session, H.B. 621 was passed exempting goods from property taxation that resides temporarily in warehouses in a city while awaiting shipment to other locations within or outside the state. The statue allows an "opt-out" provision as a local option. The exemption automatically applies to a city unless the city does each of the following two things no later than December 31, 2007; (1) holds a hearing at which members of the public are allowed to speak for or against the taxation of goods; and (2) adopts an ordinance stating it wishes to continue taxing these goods.

The exemption applies only to goods that are owned by someone other than the owner of the warehouse where the goods are temporarily stored. Some appraisers in Texas are predicting a large fiscal impact for this exemption based on the theory that retailers who currently own their own warehouses may be tempted by the language of the exemption to sell their warehouses to third-party "shell" corporations. Once ownership is thus separated, the theory goes; the retailer could claim the exemption at warehouses that essentially remain under the control of the retailer, which is not in keeping with the economic development spirit of the bill. To further complicate matters, the bill that passed this year is arguably broader than the constitutional amendment adopted by voters in 2001: the amendment prohibits the exemption where the warehouses are owned or controlled by the owner of the goods, while the 2007 bill omits the language relating to control. As a result of this confusion, the Senate sponsor of the 2007 legislation has asked for an attorney general's opinion regarding the scope of the bill in relation to ownership and control.

The law can be very broad in its impact. The Central Appraisal District does not know the level of loss to taxable value because of the varying interpretations on what will be covered. It has potentially damaging loss as agents will be pushing this as far as they can legally and we expect numerous lawsuits and appeals before the impact is known.

Council and staff discussion included: 1) by passing the following ordinance it will not allow this exemption to go into affect; and 2) if no action taken it would go into effect January 1.

Mayor Archibald opened a public hearing on the item and there being no one Mayor Archibald closed the public hearing.

Councilman Chase made a motion to approve an Ordinance amending Chapter 30, "Taxation", Article I, of the Abilene Municipal Code. Councilwoman Davis seconded the motion, and the motion carried.

4.2 Ken Dozier, Fire Chief briefed the council on the request for additional information on the rate increase from MetroCare. The increase of rates will not impact the city's budget. Ambulance users will see a rate increase per the request presented.

Mayor Archibald opened a public hearing on the item and the city council heard from:

- George Knupple, General Manager for MetroCare. Discussion included: 1) collection of past due accounts; 2) options for collecting the past due accounts; 3) when someone calls for an ambulance they do not turn anyone down; 4) hired a collection agency to collect past due accounts; 5) when MetroCare took over from Rural Metro in May 2004 they used the same rates Rural Metro had been using; 6) costs of upkeep of the vehicle maintenance; 7) fleet of 9 ambulances, 2 support vehicles and 1 disaster trailer; 8) one of the few services that is self supporting; 9) MetroCare is only located in Abilene; 10) rate request is based upon need of the company and not in comparison to other services; and 11) have paramedics on each ambulance so that the care being given is ALS 2 (Advance Life Support).
- Dr. Robert Larson, Emergency Medicine at Hendrick Medical Center. Dr. Larson explained that the level of care that has been given patients has greatly increased since MetroCare has taken over. MetroCare has saved lives here in Abilene. MetroCare does a great job and Abilene is very fortunate to have them here. Dr. Larson stated that he sees a very different level of care being delivered versus the rural ambulance services. Dr. Larson asked that the city council support the rate increase for MetroCare.

There being no one else present and desiring to be heard Mayor Archibald closed the public hearing. Council would like to have a report in 6 months to see how things are going.
