CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on November 17th at 8:30 a.m. in the Council Chambers at 555 Walnut Street. Mayor Archibald was present and presiding with Councilmen Shane Price, Joe Spano, Robert O. Briley, Anthony Williams, Stormy Higgins and Councilwoman Kellie Miller. Also present were City Manager Larry Gilley, City Attorney Dan Santee, City Secretary Danette Dunlap, and various members of the City staff.

Oral Resolutions:

- **Oral Resolution -** City Council approved the purchase of emergency medical dispatching software from a sole source vendor Priority Dispatch Corporation in the amount of \$127,079.50.
- **6.5 Oral Resolution** City Council authorized the City Manager to execute contracts for On-Demand General Engineering Services. With each of Brian Parks and Associates, Meers Engineering, Inc and WTA, Inc Consulting Engineering.
- **Resolution** City Council approved the lease purchase agreement for the purpose of procuring computers for public safety vehicles.

Current computers in use in patrol vehicles are five years old, at the end of their life cycle, and are increasingly beginning to fail. The previous computer provider, L-3, is no longer in business and replacement computers and/or parts are unavailable. We are ready to implement the first phase of a project to replace the vehicle computers with Panasonic "Tough Book" laptop computers that will be leased/purchased over a three year period. The first phase addresses replacing twenty (20) of the computers. The entire project will encompass replacing approximately eighty (80) computers that are deployed in public safety vehicles. The new computers will increase bandwidth and allow use of web based data sources for intelligence led policing, which is not currently available in patrol units. Additionally, these computers will provide access from the vehicle to the Police Department's records management system. The computers will be purchased from Toner Tiger, a local vendor that meets bidding requirements as a member of the State of Texas Department of Information Resources Cooperative Purchasing Program for state and local governments. The lease financing will be accomplished through DivLend Equipment Leasing.

Funding for this lease purchase agreement first year's payment of \$36,926.24 is included in the FY 2012 Technology Fund previously approved by Council in September 2011. Two additional payments of \$36,926.24 will be budgeted for and made in FY 2013 and FY 2014.

Resolution <u>#21-2011</u> and captioned as follows:

6.7 Resolution - City Council approved their Official intent to reimburse costs regarding the purchase of a Fire Engine. The City of Abilene Fire Department is proposing to purchase one fire engine to replace one that was damaged and placed out of service in July 2010. To be able to proceed with this award of bid prior to the sale of the certificates of obligation, the attached resolution needs to be approved by the City Council. The Resolution allows us to enter into a contract prior to the delivery of the certificates of obligation funds.

The certificates of obligation to support any cost associated with this purchase are expected to be sold early next year. Funding for this purchase will be paid out of the Fire Apparatus Replacement Fund. The cost to the fund will be reimbursed upon delivery of the certificates of obligation funds.

REGULAR AGENDA

7.1 Leslie Andrews, briefed the council on the Ordinance for the Standards of Care.

The Standards of Care require three inspections/review levels be performed each year to insure compliance. The first level is performed by the Recreation Coordinator to confirm adherence to the Standards themselves. The second is a visual inspection of the facilities to be conducted by the program Administrator with the assistance of a certified leisure professional not associated with the City of Abilene. That visual inspection was conducted on September 30, 2011. The Certified Parks and Recreation Professional who assisted was Carl White, Parks and Recreation Manager for San Angelo, Texas. The third level is an annual

inspection by both the Fire Department and Environmental Health. All of these inspections and reviews were satisfactorily completed and the program is in compliance. Mr. White offered a few suggested improvements the staff is planning to implement in the coming year. These include: (1) Add the City Council adoption date to page one of the document. (2) Update the document to reflect current reporting practices. (3) Update staff training on use of fire extinguisher.

Parks and Recreation Board and Staff both recommend approval.

Mayor Archibald opened the public hearing and there being no one present and desiring to be heard the public hearing was closed.

Councilman Williams made the motion to approve the ordinance for the Standards of Care. Councilman Higgins seconded the motion, motion carried.
