- **Oral Resolution:** Council approved a fireworks display permit from Extreme Pyrotechnics for an event to be held at Abilene Christian University on October 19, 2012.
- **Oral Resolution:** Council approved a Street Use License for Pioneer Drive Baptist Church closing Buccaneer Drive on October 31, 2012 from 4:30 pm to 10:00 pm.

Pioneer Drive Baptist Church has submitted a Street Use License (SUL) application to hold their annual "Fall Family Fun Night" event within the public right-of-way on Buccaneer Drive. The applicant wishes to close Buccaneer Drive from the north right-of-way line of Potomac Avenue to the south right-of-way line of South 7th Street for this event. The event will take place on Wednesday, October 31st, 2012 from 6:00 p.m.-8:00 p.m., and the applicant wishes to close the street between the hours of 4:30 p.m. and 10:00 p.m. on this date. Pioneer Drive Baptist Church occupies the entire west side of the requested portion of Buccaneer Drive, and Bonham Elementary School/AISD occupies the entire east side. No residences or businesses are located on the requested portion of Buccaneer Drive, and the applicant has obtained the approval of Bonham Elementary School/AISD for this event.

**Oral Resolution:** Council approved a Street Use License for McMurry University for 2012 Football Season, closing Ross Avenue.

McMurry University (McMurry) has submitted a Street Use License (SUL) application for control of vehicular access to Ross Avenue for the remaining home football games at McMurry Wilford Moore

Stadium during the 2012 football season. This SUL Agreement will allow McMurry to control the traffic on Ross Avenue between Hunt Street and South 16<sup>th</sup> Street, from 10:00 a.m-6:00 p.m. on 10/27/12, 11/3/12, 11/10/12 and 11/17/12. McMurry University owns the property on both sides of the requested portion of Ross Avenue. No residences or businesses are affected by this request.

**Oral Resolution:** Council approved a Street Use License for The Center for Contemporary Arts on November 2, 2012, closing Cypress Street from 5:00 pm to 11:00 pm.

The Center for Contemporary Arts has submitted a Street Use License (SUL) application to hold a public event entitled "Dia de los Muertos" within the public right-of-way on Cypress Street. The applicant wishes to close Cypress Street from the north right-of-way line of North 2<sup>nd</sup> Street to the south right-of-way line of North 3rd Street for this event. The event will take place on Friday, November 2nd, 2012, and the applicant wishes to close the street between the hours of 5:00 p.m. and 11:00 p.m. on this date. The applicant has obtained the approval of all affected property owners and/or business tenants for this event.

- **6.8 Bid Award: CB-1302** Council approved the purchase of 300 gallon automated refuse containers. To be purchased from Rotational Molding Inc. at a price of \$191,025.00.
- **6.9 Bid Award: CB-1303** Council approved the construction contract for the Miscellaneous seal coat project for 2013. Contract is awarded to J. H. Strain & Sons, Tye, Texas in the amount of \$3,024,927.82.

This construction contract involves a seal coat of the existing pavement as outlined in the Construction Plans. Type "D" HMAC is set up on this project should the contractor encounter any pavement failures or as a level up as directed by the City Engineer.

### **REGULAR ITEMS**

7.1 Jon James Director of Planning and Zoning, briefed the council on the Ordinance for the Case No. **Z-2012-22** a request from Simon Moreno, Sr., to rezone property from LI (Light Industrial) to MD (Medium Density), located at 441 & 501 Bois D 'Arc Street.

Currently the properties are zoned LI but had been developed with single-family residential homes. The surrounding properties had been developed similarly. This site and surrounding properties were previously zoned RM-2 (Multi-Family Residential) and developed with single-family homes. The zoning was changed to LI (Light Industrial) in December of 1977 making residential uses no longer permitted. The existing home has been considered a legal non-conforming use of this property. As such, a home cannot be reconstructed at this same location if damaged more than 50% of the building's appraised value. A recent fire at this home has completely destroyed it.

The Future Land Use section of the Comprehensive Plan designates this general area for heavy commercial/industrial activity. However, the primary uses in the immediate area have remained residential. Staff has begun a review of the existing zoning districts city-wide and determined that the zoning for this area could be reconsidered to change from LI to the MD (Medium Density) zoning given the lack of interest shown for industrial development in this area. The requested zoning would be compatible with the surrounding uses and would be more appropriate with the existing residential uses in the immediate area.

Mayor Archibald opened the public hearing there being no one present and desiring to be heard the public hearing was closed.

Councilman Price made the motion to approve the Ordinance for the Case No. **Z-2012-22** a request from Simon Moreno, Sr., to rezone property from LI (Light Industrial) to MD (Medium Density), located at 441 & 501 Bois D 'Arc Street. Councilman Spano seconded the motion, motion carried.

Location: 441 & 501 Bois D' Arc Street

7.2 Jon James Director of Planning and Zoning, briefed the council on the Ordinance for the Case No. **Z-2012-23** a request from Bill Ortega & Elisa Bontke, to rezone property from MD (Medium Density) to MD/H (Medium Density/Historic Overlay), located at 782 Palm Street.

The property is zoned MD and has been developed with a residential dwelling unit. The 1-1/2 story Queen Anne Victorian Cottage was built in 1909 by Wesley E. Hargrove. The large framed structure has an irregular design with a hipped roof, dormer and gable windows, and a columned wrap-around porch with a characteristic rounded corner. Recently, the current owners, Bill Ortega & Elisa Bontke, have begun restoring the interior of the home and are planning to begin work on the exterior. They are requesting Historic Overlay Zoning after gaining more information regarding the responsibilities and benefits of the zoning.

The Future Land Use section of the Comprehensive Plan designates this general area as low-density residential. The requested zoning is an overlay zoning that would not affect the underlying residential zoning and would be compatible with the surrounding land uses. Other properties in the area have received Historic Overlay Zoning, and this request could encourage other properties to do the same.

Mayor Archibald opened the public hearing and there being no one present and desiring to be heard the public hearing was closed.

Councilman Higgins made the motion to approve the Ordinance for the Case No. **Z-2012-23** a request from Bill Ortega & Elisa Bontke, to rezone property from MD (Medium Density) to MD/H (Medium Density/Historic Overlay), located at 782 Palm Street. Councilwoman Miller seconded the motion, motion carried.

Ordinance #48 -2012

**7.3** Jon James Director of Planning and Zoning, briefed the council on the Ordinance Amending the Land Development Code related to Urban Gardens.

Urban farming has gained popularity recently as a way to use under-utilized property while supporting a self-sustaining land use. Several inquiries have been made to staff about community gardens and urban farms being located on vacant lots throughout the city. Currently, community gardens and urban farms are not permitted. Specifically, the City's ordinances do not allow for a water meter to be issued for a vacant lot.

Staff is proposing to allow community gardens/urban farms by right in the majority of the zoning districts so long as they meet specific regulations to mitigate potential negative impacts. The use would allow for

cultivation of fruits, flowers, vegetables, or ornamental plants by one or more person or family, to include organizations such as non-profits or churches.

The use is currently not listed in the Land Use Matrix. It is proposed to be included and identified as 'Urban Garden'. The sections proposed for amendment are Section 2.4.2.1 –Land Use Matrix, Section 2.4.3.3 – Specific Requirements, and Section 5.1.1.3 – Land Use Definitions.

Council and Staff discussion included: 1) the use of City owned property that is vacant, being used by non-profit organizations; and 2) Storage buildings, buildings that don't require a building permit can be placed on these lots.

Mayor Archibald opened the public hearing and city council heard from:

- Josh Casey spoke in favor of the change, asked about allowing a wash-up sink for those that come to tend the garden.
- Wes Grigsby spoke in favor of the change.

There being no one else present and desiring to be heard the public hearing was closed.

Councilman Higgins made the motion to approve the Ordinance amending the Land Development Code related to Urban Gardens. Councilman Williams seconded the motion, motion carried.

Ordinance #49 -2012

7.4 Presentation by Paul Johnson. Mr. Johnson land owner - requested that the City Council review and consider adding a left hand turn lane off of South 14<sup>th</sup> into the Frenchman's Creek Shopping Center between 7-11 Convenience Store and Hastings. The following citizens spoke in support of the addition of a left turn lane: Darlene Ortiz General Manager for Little Italy, Lodovik "Luigi" Tetaj owner of Little Italy, and Anna Humphrey Property Manager for Frenchman's Creek Shopping Center.

Mayor Archibald explained that the council would not take action today on this item. Council has directed staff to review and put together a cost analysis for this request.
