The City Council of the City of Abilene, Texas met in Regular Session on July 25th, at 8:30 a.m. in the Council Chambers, 555 Walnut St. Mayor Archibald was present and presiding with Councilmen Shane Price, Joe Spano, Anthony Williams, Robert O. Briley, Kyle McAlister and Councilwoman Kellie Miller. Also present were City Manager Larry Gilley, City Attorney Dan Santee, City Secretary Danette Dunlap, and various members of the City staff.

Councilwoman Kellie Miller gave the invocation.

Oral Resolutions:

Oral Resolution: The City Council acknowledged and accepted the 9-1-1 Emergency Communications District Revised FY 2013 and Proposed FY 2014 budgets.

The City of Abilene manages the Abilene/Taylor County 9-1-1 District ("the District"), via contractual agreement with the District's Board of Governors. The V.T.C.A. Health & Safety Code, Section 772, provides that an annual budget be prepared for the District and reviewed and accepted by the Taylor County Commissioners Court, Abilene City Council, and governing bodies of other participating jurisdictions prior to adoption by the District Board. Attached is the District Budget (revised 2013 and Proposed 2014) as proposed to the District Board. Highlights in the District's budget include:

- Anticipated compensation adjustments for both City and County positions for which the District provides funding, in accordance with those entities' budgets (proposed)
- Major equipment upgrade purchases for both the City of Abilene and Taylor County communications centers. This upgrades the 9-1-1 call taking and recording equipment to current technology, as well as provides for redundant (backup) communications connectivity between the LEC communications centers, the communications provider and the alternate site at City Hall.

REGULAR ITEMS

7.1 Council heard from Anna Claire Boone, Mattie Smith and Kaylee Beard 5th grade students from Wylie Intermediate School who presented their results from a project from their class. Their class project was "Curbside Recycling in Abilene". The girls presented the petition where they had collected 1200+ signatures of interested citizens for curbside recycling.

They explained that there are several ways that it could be collected: 1) single-stream where the resident doesn't sort their garbage at home. The garbage would be sorted at a separate location for sorting; and 2) or one day a week when recyclables can be collected instead of regular garbage.

Megan Santee Director of Public Works briefed the council on the current recycling that the city does. There are 8 locations throughout the city for recycling paper, cardboard, glass and cans.

Council and Staff discussion included: 1) curbside would we collect only residential or would we also handle commercial accounts; 2) also the startup cost of purchasing equipment; 3) what are our peer cities doing?; 4) \$271,000 is the revenue received from current recycling program; 5) 2.3 million in landfill fees; 6) research shows approximate 23 to 26% reduction in tonnage through recycling; and 7) Waste to Energy program – where the city would take garbage to a site that would sort and the garbage is used for generating energy.

No action on this item.

7.2 Megan Santee Director of Public Works briefed the council on the application/permit to drill and/or Operate an Oil and/or Gas well (3) Bullet Development LLC, "WTRC#4", "WTRC#5", "WTRC#6", Permit #'s 759330, 759333, 759335.

Chapter 21, Oil and Gas, of the City Code requires a permit for drilling and operating oil/gas wells within the city limits. As part of the review process, the City Council is to conduct a public hearing and then approve or deny the permit.

Bullet Development, LLC of Abilene, Texas has submitted applications to drill the "WTRC #4", "WTRC #5" and "WTRC #6" wells on property owned by Jack Denson, located on East Industrial Blvd. southeast of Diamondback Golf Club and south of Abilene Regional Airport. Because of the proximity to Abilene Regional Airport, a Federal Aviation Administration (FAA) Aeronautical Study was required for each well. The aeronautical studies are attached to, and made part of each application/permit. The studies concluded that the drilling rig for each well does not exceed obstruction standards and would not be a hazard to air navigation, provided that the

marking/lighting and notification requirements detailed in the studies are met. Additionally, although the eastern portion of the WTRC oil & gas lease boundary is on City of Abilene/Abilene Regional Airport property and within the airport perimeter fence, when the City purchased this tract for the airport in 1967 it received exclusive rights to use of the surface, including the rights to control ingress & egress for exploration of oil & gas. Therefore, this area cannot be accessed for drilling.

These applications have been reviewed and approved by City Staff. All owners of real property within 500 feet of the proposed drill sites have been notified of these applications and of the City Council meeting to consider their approval, as required by City ordinance.

Mayor Archibald opened the public hearing and Larry Wellhausen was present for any questions regarding the application. Mayor Archibald closed the public hearing.

Councilman Price made the motion to approve the application/permit to drill and/or operate an oil and/or gas well (3) Bullet Development LLC, "WTRC#4", "WTRC#5", "WTRC#6", Permit #'s 759330, 759333, 759335. Councilman Williams seconded the motion, motion carried.

7.3 Megan Santee Director of Public Works briefed the council on the application/permit to drill and/or operate an Oil and/or Gas well – Sojourner Drilling Corporation, "Impact Unit 3, Well No. 4", Permit No. 761918.

Chapter 21, Oil and Gas, of the City Code requires a permit for drilling and operating oil/gas wells within the city limits. As part of the review process, the City Council is to conduct a public hearing and then approve or deny the permit.

Sojourner Drilling Corporation of Abilene, Texas has submitted an application to drill the "Impact Unit 3, Well No. 4" on property owned by Rogelio Gonzales located at 3896 Clinton Street, at the southwest corner of the intersection of Clinton Street and Roosevelt Street. This well is being drilled under the applicant's 43.59 acre "Impact Unit 3" lease, comprised of multiple property and mineral interest owners as detailed within the supporting documentation for the permit application. The applicant is requesting a variance per sections 21-26 and 21-27 of Chapter 21 of the City of Abilene Code of Ordinances, Oil and Gas, to drill within 200 feet of existing buildings and residences, and the applicant has provided the notarized written consent of the owner of each residence within a 200 ft. radius of the well location, as required by ordinance. Additionally, the applicant was requested to provide, and has provided a mineral interest title opinion verifying that the City of Abilene owns no mineral or royalty interest in/under the streets and alleys within the 43.59 acre unit area. This application has been reviewed and approved by City Staff. All owners of real property within 500 feet of the proposed drill site have been notified of this application and of the City Council meeting to consider its approval, as required by City ordinance.

Mayor Archibald opened the public hearing and council heard from the following citizens;

- Sheryl Minear, Regulatory Manager for Sojourner Drilling, spoke on the application and the location of the well site and addressed the concerns of the citizens speaking during the public hearing.
- Albert Leija, resident in the area and having mineral interest in the area, spoke against the permit to drill.
- Travis McClure, Land Agent for the City, spoke about the requirements of the City's ordinance and the regulations from the Railroad Commission.
- Felipe Leija, resident in the area and having mineral interest in the area, spoke also against the permit to drill

There being no one else present and desiring to be heard the public hearing was closed.

Councilman Anthony Williams made the motion to approve the application/permit to drill and/or operate an Oil and/or Gas well – Sojourner Drilling Corporation, "Impact Unit 3, Well No. 4", Permit No. 761918. Councilman McAlister seconded the motion, motion carried.

7.4 Jon James, Director of Planning and Development Services briefed the council on FY 2013/2014 One-Year Action Plan for CDBG and HOME Programs.

As an entitlement city receiving funds from the U.S. Department of Housing and Urban Development (HUD), the City of Abilene is required to submit a Consolidated Plan that strategically addresses the City's goals and objectives for housing and community development over the course of a five year period. The City of Abilene is also required to submit a One-Year Action Plan outlining specific uses of Community Development Block Grant (CDBG) and Home Investment Partnerships Program (HOME) funds planned for the coming fiscal year. The Office of Neighborhood Services Advisory Council was instrumental in the development of the goals and objectives of the Consolidated Plan, which were adopted by Council on May 22, 2010. The One-Year Action Plan must be submitted to HUD by August 15, 2013.

A public hearing was held on March 6, 2013, at City Hall to discuss/determine services, needs and gaps in the following areas of concentration which included housing, homelessness/special needs, economic development, and community development/neighborhood development. At this session, representatives of nonprofit agencies and members of the general public made various comments on community development needs for consideration for CDBG/HOME funds or alternative funds. A summary of the One-Year Action Plan outlining the proposed FY 2012/2013 budget was published in the Abilene Reporter-News on June 10, 2013, which began the HUD required 30-day comment period. No written comments were received. A second public hearing on July 25, 2013, is required with approval of the attached resolution.

FY 2013 CDBG funds were increased .06% over 2012 funding and HOME funds were reduced 5%. Funding levels continue to be below the 2011 funding levels of 26%, which precludes funding for city public services and outside agencies. There will be no impact on local taxes. Projects will be funded using FY 2013 CDBG entitlement of \$876,072, with a Reserve of \$24,364 for Section 108 debt repayment and HOME entitlement of \$371,629, with \$101,578 reprogrammed funds. In addition, the City anticipates that it will receive \$20,000 from HOME program income during FY 2013/2014.
