The City Council of the City of Abilene, Texas met in Regular Session on July 24th, 2014, at 8:30 a.m. in the Council Chambers, 555 Walnut St. Mayor Archibald was present and presiding with Councilmen Shane Price, Joe Spano, Anthony Williams, Jay Hardaway, and Kyle McAlister. Councilwoman Kellie Miller was absent. Also present were City Manager Larry Gilley, City Attorney Dan Santee, City Secretary Danette Dunlap, and various members of the City staff.

The City of Abilene Water Department is requesting that by written resolution the City Council approve Addendum II to the Water Supply Contract (Contract) between the City and the View-Caps Water Supply Corporation (VCWSC). Addendum II allows for increasing the Maximum Daily Flow Rate (MDFR) for Delivery Points No. 5, 6 and 8. Addendum I, approved July 23, 2009, was for the relocation of Delivery Points No. 1 and No. 8, and for the increase of the MDFR for Delivery Point No. 1.

The VCWSC, a wholesale customer of Abilene, owns a potable water distribution system serving rural customers existing primarily outside the Abilene City limit. The Contract describes eight metered Delivery Point connections to Abilene's water system. The Texas Commission on Environmental Quality (TCEQ) requires that the Contract provides adequate supply to meet the calculated demand of the retail system based on the number of connections it serves. The demand of VCWSC exceeds 85% of its contracted supply and therefore it must make plans for additional supply. The VCWSC contracted with a Professional Engineer to evaluate its distribution system, and the Engineer recommends changing the MDFR as described below:

The Engineer, along with City staff, evaluated the impact that the proposed increases of the MDFR's would have on the City's distribution system and determined that the proposed increases would not have a significant impact on current system operation, nor does it require acceleration or expansion of planned system improvements as identified in the 2010 Water Master Plan. Addendum II will increase the MDFR's as described above. All other terms, provisions, and obligations in the Water Supply Contract effective January 1, 2004, as amended, remain in force and effect.

6.16 **Oral Resolution:** The City Council awarded the bid for the Lake Abilene Dam Intake Tower Rehabilitation Project to SCR in the amount of \$189,250.00 and authorized the City Manager to execute all necessary documents related to the contract.

On June 30, 2014 the City of Abilene received bids for the Lake Abilene Dam Intake Tower Rehabilitation Project CB-1428 (Project). The Project was advertised in the Abilene Reporter News on June 15th and June 22nd, 2014. Three bids were received. The low bid was submitted by SCR Construction Company, Inc. (SCR) of Richmond, TX. The Engineer, after evaluating the bid submittal and the contractor references, does recommend awarding the bid to SCR in the amount of \$189,250.00.

On June 13th, 2013 the Abilene City Council authorized Amendment 2 to the professional services contract with Freese and Nichols, Inc. (FNI) for the Dam Upgrade Program for Fort Phantom Hill Dam, Lake Abilene Dam, and Kirby Lake Dam. Amendment No. 2 provides for second phase engineering services for the preparation of plans, specifications and contract documents for the recommended improvements and construction phase services for Fort Phantom Hill Dam and Lake Abilene Dam. The Project is an improvement resulting from Amendment 2. The dam intake tower structure was completed in 1921, and it has obvious degradation to the exterior surface resulting from continuous exposure to wave action and the elements. The Project is for the encasement of the of the dam intake tower structure using steel reinforced concrete. The current very low surface water elevation of Lake Abilene may allow the contractor full access to the structure to make the repairs. The bid documents provide for an allowance and repair options should the lake level increase before or during project construction.

6.17 **Oral Resolution**: City Council approved amendments to the required ADA Notice and Grievance.

Under Title II of the Americans with Disabilities Act (ADA), municipalities with more than 50 employees are required to designate an ADA Coordinator, provide notice about the requirements of the ADA and establish a grievance procedure. The Director of Human Resources, currently Ronnie Kidd, has served in the role of the ADA Coordinator for the City of Abilene. This oral resolution approves updates to the ADA notice and grievance procedure to ensure compliance with Title II.

## **REGULAR ITEMS**

7.1 Jon James Director of Planning and Development Services briefed the council on the FY2014/215 One-Year Action Plan for CDBG and HOME Programs.

As an entitlement city receiving funds from the U.S. Department of Housing and Urban Development (HUD), the City of Abilene is required to submit a Consolidated Plan that strategically addresses the City's goals and objectives for housing and community development over the course of a five year period. The City of Abilene is also required to submit a One-Year Action Plan outlining specific uses of Community Development Block Grant (CDBG) and Home Investment Partnerships Program (HOME) funds planned for the coming fiscal year. The Office of Neighborhood Services Advisory Council was instrumental in the development of the goals and objectives of the Consolidated Plan, which were adopted by Council on May 22, 2010. The One-Year Action Plan must be submitted to HUD by August 15, 2014.

A public hearing was held on March 4, 2014, at City Hall to discuss/determine services, needs and gaps in the following areas of concentration which included housing, homelessness/special needs, economic development, and community development/neighborhood development. At this session, representatives of nonprofit agencies and members of the general public made various comments on community development needs for consideration for CDBG/HOME funds or alternative funds. A summary of the One-Year Action Plan outlining the proposed FY 2014/2015 budget was published in the Abilene Reporter-News on June 16, 2014, which began the HUD required 30-day comment period. No written comments were received as of July 16th. A second public hearing on July 24, 2014, is required with approval of the attached resolution.

FUNDING/FISCAL IMPACT—PY 2014/15 CDBG funds were reduced 6.2% from 2013 funding and HOME funds were reduced .5%. Funding levels continue to be below the 2011 funding levels, which precluded funding for city public services and outside agencies. Section 108 Loan debt reductions this year has allowed funding of one public service and four projects in 2015. There will be no impact on local taxes. Projects will be funded with PY 2014 CDBG entitlement of \$821,588 and HOME entitlement of \$369,868 with \$353,589 reprogrammed funds. In addition, the City anticipates that it will receive \$25,000 from HOME program income during FY 2014/2015.

Resolution **#17-2014** 

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, APPROVING THE FY 2014/15 ACTION PLAN FOR THE CONSOLIDATED PLAN AND PROJECTED USE OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND HOME INVESTMENT PARTNERSHIPS PROGRAM (HOME) FUNDS

7.2 Kellie Messer Assistant City Attorney briefed the council on the Ordinance for Amending Chapter 10; Fire Protection and Prevention, Article III: Fire Prevention Code, Division 2: Smoking Restrictions of the Code of the City of Abilene.

On December 21, 2006, the City Council of the City of Abilene adopted an ordinance banning smoking in all public places and places of employment. Since that time, there has been a substantial increase in the sale and use of electronic liquid nicotine devices which are not currently regulated by state law.

The Food and Drug Administration recently determined that the smoking of electronic cigarettes and/or E-cigarettes and liquid nicotine have been demonstrated to have a detrimental effects on others in close proximity to the smoker.

The intent of the regulations Chapter 10, Article III, Division 2 is that it is the right of all citizens to be able to choose for themselves whether to smoke either actively or passively. Furthermore, it is advantageous and beneficial to the City and its citizens to provide patrons of retail and service establishments and those in public places a smoke-free environment to reduce detrimental effects on not only the smoker, but others in close proximity to the smoker and to further the health, safety and welfare of the City and its citizens

Because the State of Texas has not yet enacted legislation regulating the sale or use of electronic cigarettes, municipalities across the state have begun to do so. Among our peer cities, Carrolton (Passed new ordinance 4/15/2014), Grand Prairie (Smoking ordinance passed 1/21/2014), and San Angelo have smoking ordinances that also regulate electronic cigarettes and liquid nicotine.

Dr. Peter K. Norton, medical director with the Abilene-Taylor County public health district, said that carcinogen levels in the vapor produced by e-cigarettes are "significantly less," about one-thousandth, compared with a standard cigarette.

"So relatively speaking to the community, to people around you, it is much safer than the smoke you can get from a cigarette," he said. "... However, if you put the vapor and put it with cells, those cellular changes are similar to those with tobacco products."

But there is a lack of scientific studies, he said, that "tell us exactly what the risks are and what their safety is."

Dr. Norton also stated he had concerns about the products because e-cigarettes are often marketed toward minors, particularly teens.

Council and Staff discussion included: 1) Councilman McAlister had purchased contents for E-Cigs and discussed the contents with Dr. Norton; 2) nicotine and labeling – not regulated by the FDA; 3) Vap liquid; and 4) content of liquid is normally used for other purposes and there are not any studies conducted on the use of the liquid as an inhalant.

There was no one else present and desiring to be heard the public hearing was closed.

Council and Staff discussion included: 1) restricting the sale of E-cigarettes to minors; 2) restrictions on City property (buildings only) this could be done through policy; 3) school districts; and 4) asked that individuals vaping be mindful of where they are using the E-cigs and have respect for other non-smokers.

Councilman McAlister went on the record to say that he supports banning the use of E-Cigs in the same manner as regular cigarettes and would not vote against the motion on the floor to only prohibit the sale to minors.

Mayor Archibald made the motion to approve amending Chapter 10: Fire protection and prevention, Article III: Fire Prevention Code, Division 2: Smoking Restrictions – prohibiting the sale of E-Cigs to minors. Councilman Williams seconded the motion, motion carried.

## Ordinance #41-2014

AN ORDINANCE AMENDING CHAPTER 10: FIRE PROTECTION AND PREVENTION, ARTICLE III: FIRE PREVENTION CODE, DIVISION 2: SMOKING RESTRICTIONS OF THE CODE OF THE CITY OF ABILENE, TEXAS

## Sale of E-Cigarette's to minors is prohibited

7.3 David Sartor Building Official briefed the council on the Ordinance the adoption of the 2012 Building, Residential, Existing Building, Energy conservation, Plumbing, Mechanical and Fuel Gas Codes with Amendment.

It is recommended that the 2012 International Building Code, 2012 International Residential Code, 2012 International Existing Building Code, 2012 International Energy Conservation Code, 2012 International Mechanical Code, 2012 International Plumbing Code and 2012 International Fuel Gas Code, with local amendments, be adopted in order that the City's construction regulations are kept up to date. Local amendments pertain to licensing and administrative procedures with limited modifications made to the technical provisions of the International Codes. Each Code was reviewed by a citizen's ad-hoc committee, comprised of contractors, architects, engineers and suppliers.

Staff recommends approval.

The Mechanical, Plumbing, Electrical & Swimming Pool Board of Appeals recommends approval of the 2012 edition of the IMC, IPC and IFGC by unanimous vote at their meeting held on February 11, 2014. The Board of Building Standards recommends approval of the 2012 edition of the IBC, IRC, IEBC and IECC by unanimous vote at their meeting held on February 5, 2014.

Several local amendments eliminated due to inclusion in the 2012 code.

- Residential (and Commercial) fences 7 ft. or less in height are exempt from permit. Local amendment no longer needed
- Dwelling units with windows located more than 72 inches above grade or surface below require a minimum sill height of 24 inches above the room floor. EXCEPTIONS: Three design options available.
- Code now specifically recognizes wireless technology for interconnection of smoke detectors in dwellings.

## Residential Mechanical Plumbing and Fuel Gas

Dryer Exhaust Duct

Support spacing increased from 4 ft. to 12 ft. and now <u>requires</u> mechanical fasteners. Screws cannot extend more than 1/8 inch into the inside of the duct.

- Safety pan is no longer required on tankless water heaters. Pan is only required on storage tanktype water heaters.
- Graywater Recycling Systems provisions are now part of the code as a design option . Previously contained in an appendix chapter

## COMMERCIAL BUILDING CODE

- Size and location of identifying markings for Fire Walls modified to increase potential for markings to be seen.
- 2009 code requires automatic fire sprinkler system where upholstered furniture is displayed, stored or manufactured.
- 2012 requires automatic fire sprinkler systems when the area exceeds a specific size. (Example -Mercantile over 5,000 square feet.)
- In addition to the traditional exit sign location, low-level exit signs are now required at all means of egress for guest rooms in Group R-1 occupancies.
- Spaces beneath grandstands and bleachers are now required to be separated from seating areas by use of fire rated assemblies.
- Where separate toilet facilities are required and only one water closet is required in each facility, two family or assisted-use toilet rooms may now be provided as an alternative to male and female only.

### **ENERGY CONSERVATION CODE**

## Commercial Energy Code

System commissioning report required on large HVAC systems.

- **Exceptions:**
- Mechanical systems with total cooling capacity less than 480,000 BTU and total heating capacity less than 600,000 BTU.
- Systems listed in Section 403.3 serving dwelling units, sleeping units in hotels, motels, boarding houses or similar units.

## Residential Energy Code

- 2012 requires blower door test to verify air sealing of the building envelope.
- Proposed amendment to match 2009 code which has two options, blower door test or visual inspection option.
- Visual inspection is our current requirement.

Eave baffles must be installed to prevent attic insulation from blocking soffit vents. High-efficacy lamps required and recommendation is to use 2009 code.

- 2012 requires a minimum 75% of lamps to be high-efficacy.
- 2009 requires a minimum 50%. (Residential and commercial)

High-Efficacy Lamps – Compact fluorescent lamps, T-8 or smaller diameter linear fluorescent lamps of lamps with a minimum efficacy of:

- 60 lumens per watt for lamps over 40 watts
- 50 lumens per watt for lamps over 15 to 40 watts
- 40 lumens per watt for lamps 15 watts or less.

### MECHANICAL CODE

- Type I hood no longer required for electric cooking appliances compliant with Section 17 of UL 710B.
- Field applied grease duct enclosure cannot be used to protect a Type I hood which penetrates a ceiling if not listed and approved by the manufacturer.

#### 2012 Construction Codes – Minor changes made from 1<sup>st</sup> reading **2012 IBC** SECTION 1612 FLOOD LAOD

## **1612.3 Establishment of flood hazard areas**. [Amend the second sentence as follows:]

To establish *flood hazard areas*, the applicable governing authority shall adopt a flood hazard map and supporting data. The flood hazard map shall include, at a minimum, areas of special flood hazard as identified by the Federal Emergency Management Agency in an engineering report entitled "The Flood Insurance Study for [INSERT NAME OF JURISDICTION]," Abilene Texas dated [INSERT DATE OF ISSUANCE], January 6, 2012 Taylor County – Abilene, October 4, 2011 Jones County – Abilene as amended or revised with the accompanying Flood Insurance Rate Map (FIRM) and Flood Boundary and Floodway Map (FBFM) and related supporting data along with any revisions thereto.

#### 2012 IBC SECTION 2611 LIGHT-TRANSMITTING PLASTIC INTERIOR SIGNS

## <u>2611.1 General.</u> {Amend the second sentence as follows:}

Light-transmitting plastic interior wall signs in covered and open mall buildings shall comply with Section 402.16 402.6.4.

#### **2012 IEBC SECTION 1401 GENERAL**

### **[B] 1401.2 Applicability.** *{Amend the first sentence as follows:}*

Structures existing prior to **FATE TO BE INSERTED BY THE JURISDICTION. NOTE: IT IS** RECOMMENDED THAT THIS DATE COINCIDE WITH THE EFFECTIVE DATE OF BUILDING CODES WITHIN THE JURISDICTION July 31, 1913 in which there is work involving additions, alterations or changes of occupancy shall be made to conform to the requirements of this chapter or the provisions of Chapters 5 through 13.

Mayor Archibald opened the public hearing and there being no one present and desiring to be heard the public hearing was closed.
