## CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on July 27<sup>th</sup>, 2017, at 8:30 a.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Councilmen Shane Price, Bruce Kreitler, Weldon Hurt, Kyle McAlister, Steve Savage and Councilwoman Donna Albus. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Danette Dunlap, and various members of the City staff.

Mayor Anthony Williams gave the invocation.

#### REGULAR AGENDA

Councilman Savage declared a conflict and left the council chambers.

7.1 Alva Cox Assistant Director of Water Utilities and Kelley Waller briefed the city council on the Ordinance first reading Amending Chapter 32 "Utilities" by inserting new Article VIII Fats, Oils and Grease.

On June 19, 2013, the City of Abilene entered a Sanitary Sewer Overflow Initiative agreement with the Texas Commission on Environmental Quality (TCEQ). As required per the terms of the agreement, City staff has created a separate Fats, Oils and Grease (FOG) Ordinance to implement and enforce the FOG Program. City staff recommends amending Chapter 32 "Utilities" with the insertion of a new Article VIII "Fats, Oils, and Grease".

For many years the City of Abilene Water Utilities Department attempted to address FOG issues using the Industrial Waste Ordinance (IWO). However the IWO did not specifically address commercial restaurants which made it more difficult to effectively address FOG issues and take enforcement actions when necessary.

In order to help reduce the number of overflows and prevent further buildup of grease in the sewer system, City staff has developed the proposed FOG Ordinance (Exhibit A) in order to provide a more balanced and comprehensive approach to dealing with FOG issues.

Council and Staff discussion included: 1) public education; 2) ability to inspect as in-acted through the ordinance; 3) TCEQ requirement to come into compliance; 4) cleaning procedures for the grease traps and interceptors; 5) sampling in grease traps; 6) enforcement; 7) guidelines; and 8) no authority at Dyess.

Mayor Williams opened the public hearing and council heard from the following citizens:

- John Rosue septic hauler spoke in favor of the ordinance
- Bill Whitley City Marshall spoke in favor of the ordinance

There being no one else present and desiring to be heard the public hearing was closed.

Councilman McAlister made the motion to approve the First Reading of the Ordinance amending Chapter 32 "Utilities" by inserting new Article VIII: Fats, Oils and Grease, and setting a public hearing for August 10, 2017. Councilman Price seconded the motion, motion carried.

Councilman Savage returned to the council chambers.

7.2 Michael Rice Director of Public Works briefed the city council on the Resolution authorizing the City Manager to execute a Local Transportation Project Advanced Funding Agreement with the Texas Department of Transportation for improvements to the Northbound Loop 322 frontage road near Highway 36.

The City of Abilene has been working with Texas State Technical College (TSTC) and their development efforts on a new campus located between the Abilene Airport and Loop 322. As part of these efforts, the City of Abilene has discussed, and worked with TSTC and the Texas Department of Transportation on traffic safety concerns.

The scope of the project consists of relocation of the existing State Highway 36 exit ramp on Northbound Loop 322 to a new location approximately 2000 feet to the south, paving improvements from the new exit ramp to Highway 36, conversion of the frontage road to a One-Way, Northbound frontage road, and intersection improvements at Navajo Trail.

Council and Staff discussion included: 1) one way access roads near the new Texas State Technical College (TSTC).

Councilman Price made the motion to approve the Resolution authorizing the City Manager to execute a Local Transportation Project Advanced Funding Agreement with the Texas Department of Transportation for improvements to the Northbound Loop 322 frontage road near Highway 36. Councilman McAlister seconded the motion, motion carried.

7.3 Wayne Lisenbee Director of Capital Improvements briefed the city council on the Construction Contract with Bontke Brothers for the Stevenson Parking Lot Rehab.

The adopted 2016 Capital Improvement Budget included the rehabilitation of the parking lots at Stevenson and Scarborough Parks in support of the Splashpad Bond Projects. Jacob & Martin has provided the design for the Stevenson parking lot.

Low bid was received from Contract Paving in the amount of \$89,733. However, Bontke Brothers was within the 5% local preference by submitting an amount of \$93,786. In accordance with the recently adopted Local Preference Policy by the City Council, the bid award goes to Bontke Brothers.

Council and Staff discussion included: 1) council policy

Councilman Hurt made the motion to approve the bid for the rehabilitation of the parking lots at Stevenson and Scarborough Parks in support of the Splaslpad Bond Projects to Bontke Brothers in the amount of \$93,786. Councilman Savage seconded the motion, motion carried.

7.4 Wayne Lisenbee Director of Capital Improvements for the consideration and adoption of the 2018 Capital Improvements Program.

The 2018 Capital Improvements Program (CIP) is a five-year program that includes proposed projects in the General Fund Program in the amount of \$24,335,000. Adoption of this year's CIP only authorizes the project(s) within the first year of the Program. The 2018 Program Year includes only one project, the Kmart Remodel project. Outlying years include projects previously authorized by City Council, projects previously submitted in past CIPs, and proposed funding for various Facilities' needs.

Council and Staff discussion included: 1) AYSA project; 2) Convention Center projects; 3) Industrial Blvd (already approved in the CIP process); 4) Planning and Zoning voted to deny the CIP projects; 5) possible covered parking for the New Law Enforcement Center; 6) Street Maintenance Fee; 7) sidewalks; and 8) property purchased at Plum Street.

Mayor Williams opened the public hearing and there being no one present and desiring to be heard the public hearing was closed.

Councilman Price made the motion to approve the Resolution for the adoption of the 2018 Capital Improvements Program. Councilman Kreitler seconded the motion, motion carried.

A RESOLUTION OF THE CITY COUNCIL OF ABILENE APROVING AND ADOPTING THE 2018 CAPITAL IMPROVEMENTS PROGRAM.

Dana Schoening Director of Planning and Development Services briefed the city council on the Resolution for the FY 2017/2018 One-Year Action Plan for use of CDBG and HOME funds; FY 2017/18 Source of Funds, Public Service/Administrative Caps.

A public hearing and 4 community neighborhood meetings were held to receive input for the FY 2017/2018 Action Plan in the EOC Conference Room, located at City Hall. The needs discussed were: housing, community services, economic development, community/public facilities, public improvements and homeless services. Invitees were service providers and nonprofits, the homeless network, disability services, 211 Call for Help agencies, religious organizations/churches and neighborhood associations and City of Abilene, residents. Professionals from housing, insurance, real estate and lending were invited. All City directors and managers were invited along with all previous funding recipients. Discussion centered on the community needs that could be addressed with CDBG/HOME funds or alternative funds. Funding applications were received from March 31, 2017-May 1, 2017. A summary of the One-Year Action Plan outlining the proposed FY 2017/2018 budget was published in the Abilene Reporter-News on June 21, 2017 (which began the HUD-required 30-day comment period). As of July 17, 2017, no written comments had been received in response to the proposed Action Plan and budget as published. A second public hearing on July 27, 2017, is required with approval of the attached resolution. The FY 2017/2018 Action Plan must be received by HUD no later than August 16, 2017.

Council and Staff discussion included: 1) Code Enforcement; 2) Infill development; 3) administrative costs; 4) critical repairs; and 5) staffing.

Mayor Williams opened the public hearing and council heard from:

8.1 B) Consider on First Reading - Ordinance Approving the Proposed FY17-18 Budget. Robert Hanna City Manager briefed and recapped the discussion from the Workshop meetings from July 25 & 26. The original proposed budget in the amount of \$91,817,900 with the reduction identified as \$342,601 and the reduction of pay increase from 3% to 1 1/2% at January would be \$499,538.00 that total would be \$842,139.00 Also it was identified through motions to set aside .01 of the tax rate to be used for self insurance fund and was in the proposed budget as presented. An additional .01 tax rate increase to be set aside for the maintenance of the Convention Center in the amount of \$534,000. With the increase of the revenue of \$534,000 and the expenditure of \$534,000 plus the identified savings of \$842,139.00, this would be used to repair the auditorium sound system and the acoustics.

Councilman McAlister made the motion to approve the first reading of the Ordinance for the Proposed FY17-18 Budget in the amount of \$92,352,000 with the changes as presented with the extra .01 of tax rate to be dedicated to the Convention Center maintenance. Councilman Price seconded the motion, motion carried.
