The City Council of the City of Abilene, Texas met in Regular Session on August 10th, 2017, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Councilmen Shane Price, Bruce Kreitler, Weldon Hurt, Kyle McAlister, and Councilwoman Donna Albus. REGULAR AGENDA

Mayor Williams moved item 7.6 Street Maintenance Fee to the start of the Regular Meeting.

7.6 James Childers, Assistant City Manager briefed the city council on the updated Street Maintenance Fee.

During the course of this summer, City Staff engaged the general public, business community, and other stakeholder groups on the potential implementation of a Street Maintenance Fee to generate at least \$10.3 Million for targeted street maintenance. The feedback received from over 23 public and private meetings was used to refine a fee structure that is presented to you as a part of this item. The fee would be administered monthly via the Municipal Account Statement for both residential and commercial customers.

The council was presented with two residential fee structures: a tiered system and a flat system. The current commercial system is comprised of 6 tiers based on trip factor rating taken from the Institute of Traffic Engineers (ITE) Traffic Generation Manual for individual business locations.

The traffic impact for the private universities is proposed to be captured at a per student rate. This rate would not go into effect until July of 2018 to better align with budget preparation for the schools. Additionally, the multifamily rates will not go into effect until July in order to allow apartment operators time to factor the impact of the rate into new lease agreements.

Council and Staff discussion included: 1) propose putting the Fee on the ballot in November to allow the citizens to decide; 2) reducing the amount from the estimated \$10.3 million; 3) no election – council to make the decision; and 4) possibly to place on the May ballot.

Councilman Kreitler made the motion to allow for a public hearing by the citizens in attendance tonight. Councilman Price seconded the motion, motion carried.

Councilman Price made the motion to place the Street Maintenance Fee Referendum on the November ballot by Resolution Ordering the November 7th election. Councilman Kreitler seconded the motion, motion failed.

7.1 Alva Cox Assistant Director of Water Utilities and Kelley Waller briefed the city council on the Ordinance Amending Chapter 32 "Utilities" by inserting new Article VIII Fats, Oils and Grease.

On June 19, 2013, the City of Abilene entered a Sanitary Sewer Overflow Initiative agreement with the Texas Commission on Environmental Quality (TCEQ). As required per the terms of the agreement, City staff has created a separate Fats, Oils and Grease (FOG) Ordinance to implement and enforce the FOG Program. City staff recommends amending Chapter 32 "Utilities" with the insertion of a new Article VIII "Fats, Oils, and Grease".

For many years the City of Abilene Water Utilities Department attempted to address FOG issues using the Industrial Waste Ordinance (IWO). However the IWO did not specifically address commercial restaurants which made it more difficult to effectively address FOG issues and take enforcement actions when necessary.

In order to help reduce the number of overflows and prevent further buildup of grease in the sewer system, City staff has developed the proposed FOG Ordinance in order to provide a more balanced and comprehensive approach to dealing with FOG issues.

Based upon the council's discussion at the last meeting the following items were edited.

EDIT 1. Ordinance Exhibit A, Sec. 32-401(b). Added the following language "The City of Abilene Guidelines and Procedures document shall be reviewed annually by staff to determine if changes or updates are necessary. If so, staff recommendations shall be submitted to the City Manager for review and approval. The City Manager may consider a change to the Guidelines and Procedures document outside of the annual review period if a time-sensitive situation arises."

EDIT 2. FOG Guidelines and Procedures, Section I(B). Strike the words "and enforce" and replace with "enforce, and amend".

EDIT 3. FOG Guidelines and Procedures, Section V(B). Eliminated the requirement that Manifests must be obtained from the City by the Transporter, and inserted comma after the word "collect".

EDIT 4. FOG Guidelines and Procedures, Section V(B), Inserted comma after the word "collect".

Staff is providing the City Council with two options for adoption of the FOG Ordinance.

Staff Proposed: the City Council would adopt the Ordinance and Exhibit A, including Edit 1, and with a separate Guidelines and Procedures Document including Edit 2, Edit 3, and Edit 4 to be administered, implemented, enforced, and amended by the City Manager.

Alternative Option: The City Council would adopt the Alternate Ordinance, Alternate Exhibit A excluding Edit 1, and Alternate Exhibit B (Guidelines and Procedures Document) including Edit 3 and Edit 4, and excluding Edit 2, thus requiring that the City Council approve of any future amendments to all documents.

Council and Staff discussion included: 1) based off of the TCEQ program; 2) 2 options; 3) transporters from outside the city; 4) manifest documents; 5) camera for inspections; 6) generators; 7) enforcement; and 8) bring the guidelines to the council for any amendments.

Mayor Williams opened the public hearing and council heard from the following citizens:

7.2 Dana Schoening Director of Planning and Development Services briefed the city council on the Ordinance for Case #Z-2017-15 a request from Hubert E. Young, Todd Lancaster, Ronald Grigsby, Robert W. Bails, George R. Jackson, Keith and Melyssa Lafontaine, and Jared and Regina Wall, agent City of Abilene, to rezone property from AO (Agricultural Open Space) to RS-8 (Residential Single-Family, minimum 8,000 square foot lots), located at 5126, 5134, 5142, 5150, 5202, 5210, and 5218 Rio Mesa Dr.

The applicants are requesting to rezone property from AO (Agricultural Open Space) to RS-8 (Residential Single-Family, minimum 8,000 square foot lots) zoning. The property consists of seven lots (1.738 acres) described as Lots 1 and 2 of Block C, Southern Meadows Addition, and Lots 3, 4, 5, 6, and 7 of Block C, Southern Meadows Addition Section 3.

Staff Recommends approval.

Dana Schoening Director of Planning and Development Services briefed the city council on the Ordinance for Case # Z-2017-16 a request from Weatherbee Construction, Inc., agent Enprotec/Hibbs & Todd, to amend the terms and conditions of PD111 (Planned Development 111) to allow for GR (General Retail) uses, legal description being 6.23 acres - at the corner of Dub Wright Blvd and Jennings Drive.

The applicant is seeking to amend the terms and conditions of PD111 (Planned Development 111), with a base zoning of O (Office) to allow for GR (General Retail) uses within PD111 (Planned Development 111). The original PD111, Ordinance No. 35-2006, was approved in 2006 with a base zoning of O (Office). The property has remained vacant and undeveloped.

Staff recommends approval
