The goal of the Governor's Criminal Justice Division (CJD) is to provide needed funding to improve public safety and support victims of crime by filling system gaps and promoting innovative solutions to common problems. In 2017, in response to the July 7th 2016, shooting of numerous police officers in Dallas, Texas, the Legislature passed and the Governor signed Senate Bill 12, which created a grant program within the governor's office to increase the safety of Texas law enforcement officers by assisting agencies in the purchase of rifle-resistant body armor. CJD is now accepting applications for projects under this program. The deadline has been extended for the submission of the application.

6.2 <u>Resolution:</u> Authorizing the continuation of a rental contract with United Rentals for two temporary pumps for the Buck Creek Pump Station. *Councilman Savage pulled this item*.

The rental contract was initiated on an emergency basis in order to restore the pumping capacity lost due to the catastrophic failure of the west screw pump. The expenditure associated with the rental contract will exceed \$50,000 in value and thus requires the approval of the Abilene City Council. It is estimated that the rental pumps may be necessary for up to 12 months resulting in a total expenditure not to exceed \$225,000.

Council and Staff discussion included: 1) what would be the cost to purchase the pumps that are being rented; and 2) the value of having these pumps on hand if purchased.

#### **REGULAR AGENDA**

7.1 Rodney Taylor Director of Water Utilities briefed the city council on the Resolution awarding a bid to Lupe Rubio Construction Company for the Industrial Boulevard Waterline Replacement Project.

The City contracted with Jacob and Martin Engineering, LLC (JM) for the design, preparation of plans and contract documents, bidding assistance, project supervision (not RPR), and project administration for the replacement of approximately 4,600 feet of 12inch diameter cast iron pipe with 12inch PVC pipe. Lupe Rubio Construction Company submitted the lowest qualifying bid totaling \$835,054.65. JM verified references and does recommend awarding the bid to Rubio.

Council and Staff discussion included: 1) water line doesn't go East from Treadaway to Maple Street; 2) after the water line then Public Works will begin the street rehab in early 2018; and 3) on this contract and contracts going forward the City will do the quality control supervision along with the checks of water line installations.

7.2 Dana Schoening Director of Planning and Development Services briefed the city council on the Ordinance for OAM-2017-02, Amendment to the Land Development Code (LDC) regarding Section 2.4.2.1 "The Land Use Matrix", Section 2.3.2.9 Residential Multiple-Family, and 2.4.3.3 'All Other Uses Without Specific Requirements' pertaining to changing Residential Uses- Dwelling-Multiple-Family (24 units per acre), 'P-Permitted' to allowed with a 'C-Conditional Use Permit' in CU (College & University), O (Office), NO (Neighborhood Office), GR (General Retail), MU (Medical Use), CB (Central Business) MX (Mixed Use) and NR (Neighborhood Retail) zoning districts.

# STAFF RECOMMENDATION

Staff recommends amendment to the Land Development Code that changes MF (Multiple-Family) as a Permitted (P) use to Conditional Use Permit (C) in certain non-residential zoning districts to include NO, 0, NR, and GR zoning districts.

Alternate recommendation if City Council would like to consider would be to delay the effect of the ordinance for one year that changes MF (Multiple-Family) as a Permitted (P) use to Conditional Use Permit (C) in certain non-residential zoning districts to include NO, O, NR, and GR zoning districts.

# BOARD OR COMMISSION RECOMMENDATION

On August 7, 2017, the Planning and Zoning Commission considered and recommended approval of MF as a conditional use in NO, O and NR zoning districts. MF as a conditional use in GR, is conditional with provision of a two-year grace period upon ordinance approval to obtain vested right for MF as a permitted use by-right, with an additional three years from the end of the two-year grace period as vested right by a vote of five (5) in favor (Smith, Famble, Rosenbaum, Calk, Noonan) and none (0) opposed

Mayor Williams opened the public hearing and there being no one present and desiring to be heard the public hearing was closed.

AN ORDINANCE AMENDING CHAPTER 8, CONSTRUCTION REGULATIONS, DIVISION 6, MINIMUM STANDARDS FOR BUILDINGS AND STRUCTURES, SECTION 8-557 REMEDIES AS SET OUT BELOW; PROVIDING FOR SEVERABILITY CLAUSE; DECLARING A PENALTY; AND CALLING FOR A PUBLIC HEARING.

7.3 Dana Schoening Director of Planning and Development Services briefed the city council on the Ordinance for Case #Z-2017-17 a request from AJWO, Inc., c/o Tom Lindley, agent Chris Barnett, to rezone 12.064 acres from AO/COR (Agricultural Open Space/Corridor Overlay) to GR/COR (General Retail/Corridor Overlay), located at 4250 Forrest Hill Road, the northeast corner of the intersection of Forrest Hill Road and Buffalo Gap Road.

The applicant's request is to rezone property from AO/COR (Agricultural Open Space/Corridor Overlay) to GR/COR (General Retail/Corridor Overlay), in order to provide more retail land uses along Buffalo Gap Road and in close proximity to Antilley Road. Currently, the property is undeveloped. The adjacent properties

have RS-6 (Single-Family Residential) to the east, PD-37/COR to the south, PD-142/COR to the west, and AO/COR and GR/COR to the north. Additionally, there is a large portion of the property (approximately 6+ acres) located in the floodway and another portion dissected by a large, electric highline easement. Staff feels that these two factors will provide a buffer from the retail uses that may develop on the property from any adjacent single-family uses. The applicant states, "only 3.5+/- acres out of the 12.064 are developable due to these constraints."

# STAFF RECOMMENDATION

Staff recommends approval.

# BOARD OR COMMISSION RECOMMENDATION
