# CITY COUNCIL MEETING December 7, 2017 at 4:30 p.m.

# CITY COUNCIL OF THE CITY OF ABILENE, TEXAS COUNCIL CHAMBERS, CITY HALL

The City Council of the City of Abilene, Texas met in Regular Session on December 7, 2017, at 4:30 p.m. in the Council Chambers, 555 Walnut St. Mayor Anthony Williams was present and presiding with Mayor Pro-tem Shane Price and Councilmembers Bruce Kreitler, Weldon Hurt, Kyle McAlister, Steve Savage, and Donna Albus. Also present were City Manager Robert Hanna, City Attorney Stanley Smith, City Secretary Rosa Rios, and various members of the City staff.

### **EXECUTIVE SESSION**

6.2 Ordinance: (First Reading) CUP-2017-01 A request from Jeffery & Margaret Martinez, agent Andrew Valdez for Conditional Use Permit to allow 'Light Manufacturing' on property zoned HC (Heavy Commercial), legal description being Lot 1 in Block 8 of the Pasadena Heights Addition, and located at 1900 E. Clayton Farrow/Jacob and Martin, to rezone property from AO (Agricultural Open Space) to RS-6 (Residential Single Family). Legal description being 45.877 acres out of the northwest quarter of L.A.L. Survey 14, and located at 7681 Maple Street, and east from the southeast corner of Maple Street & Colony Hill Road; and setting a public hearing for December 21, 2017

Legal description being, Lots 7-10 in Block 17, Original Town, City of Abilene, Taylor County, Texas, and located at 201 Mesquite Street and 203 Mesquite Street; and setting a public hearing for December 21, 2017

### REGULAR AGENDA

7.1 Ordinance & Public Hearing: (Final Reading) Approving the Standards of Care for 2018 (ASSIGNED ORDINANCE NO. 46-2017)

Lesli Andrews, Director of Community Services, presented the item. The changes since the last presentation/discussion were outlined: 1) All references to www.abilenetx.com have been changed to www.abilenetx.gov; 2) Page 3 - changed website to www.abilenetx.gov/camps; 3) Pages 6 and 7 - changed from "successfully completed" to "current certification" for First Aid and CPR; and 4) Pages 13 and 14 changed Texas Department of Health to "Texas Department of State Health Services". Clarification was provided on the background check results showing convictions but not arrests. Additional discussion centered on the eligibility of an applicant being hired will depend on the offense, and arrests alone do not disqualify an individual. Because of the adjudication process that can come to play, an individual has the opportunity to apply at a later date.

Mayor Williams opened the public hearing. With no speakers coming forward, Mayor Williams closed the public hearing.

Mayor Pro-tem Price moved to approve the ordinance. Councilmember Savage seconded the motion; motion carried.

7.2 Resolution: Authorizing a Contract for the Water Distribution System Evaluation, Modeling, and Master Plan 2018

(ASSIGNED RESOLUTION #148-2017)

Rodney Taylor, Director of Water Utilities, presented the item. Discussion centered on the master plan serving to ensure upkeep of the projects once identified and prioritized. Clarification was provided that while the form used by the city to seek services notes the need to have workers comp, but if the law does not require that it be provided, the vendor is not required to provide it. The water model currently in place, purchased some 10 years ago, was on target on what was identified; this model is expected to last some 15-20 years. The expectation is that the city is keeping up with the modeling identified in its plans, the plan/intent is that the modeling software will stay current and updated on a daily basis as maintenance activities occur.

Councilmember McAlister moved to approve the item as presented. Councilmember Savage seconded the motion; motion carried.
