Lesli Andrews, Director of Community Services, presented the item. Approval of the item would cover the base bid of \$167,750 for the Lake Kirby Nature Park construction; staff continues to seek grants as additional funding options for other improvements.

Mindy Patterson, Assistant City Manager, presented the item. Discussion centered on (1) firm's qualifications; (2) audit being performance-based, not financial-based; (3) if adopted, the audit would not be reflective of the confidence level held in the Abilene Convention and Visitors Bureau, Abilene Cultural Affairs Council, and Abilene Chamber of Commerce.

At Mayor Pro-tem Price's request, Mayor Williams opened the item for public comment. The following addressed the city council:
