Wylie ISD is required to improve substandard perimeter streets adjacent to that new school, while the City is required to participate in the costs of perimeter roads that are in excess of a Developer's fair share.

In-depth discussion was held on the stipulations outlined in the Memorandum of Agreement (MOA) executed on April 5, 2016 between the City and AYSA. The stipulations were not all included in the proposed agreement being presented. Confirmation was provided that delaying the item would have no detrimental effect on the project. The delay would allow the City and AYSA to regroup with all applicable parties and revisit the stipulations of the MOA and their applicability to the proposed lease agreement.

Adoption of the item would allow an objective review and quantitative analysis of the Abilene/Taylor County behavioral health and criminal justice systems. Costs for the study would be covered by: (1) The Dodge Jones Foundation at \$40,000; (2) The Diane Owen Graves Foundation at \$40,000; (3) City of Abilene at \$10,000; and (4) Hendrick Medical Center at \$10,000. The needs assessment is necessary in order for the City to apply for federal grant funding to help address mental health needs in the community.
